

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Reason for change:

Recommended changes:

Caldhame Plantation should be made a protected area as per planners recommendations in the initial draft. As has been shown by previous local plans most people who stay in the village do not want building in this area and want it protected. It was classified as an ancient woodland. Some trees were felled and the felling licence specifically states these must be replanted by early 2021. Although there has been previous support for building in this area the majority of this comes from people who do not live in the village. The area also needs to be protected to preserve the protected wildlife that lives in it including bats, red squirrel, pine martens and owls to name a few.

OP3 should be deleted from the plan. OP1 & OP2 have not yet been built on and there has been no demand for building in the village. There is absolutely no need or justification to add on another location when a small village already has capacity for 56 homes. This existing capacity will already change the nature of the village without adding on yet more capacity.
