

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Reason for change:

Having discussed with the Local Plan team we realise that there is still a Future Opportunity for bid site BU033 to be developed, depending on when the LDP review takes place.

The site is being marketed and we continue to engage with developers, most of whom state that 20 homes is too small an allocation for them to consider, and it is difficult for a small developer to get on the ladder to develop this site due to infrastructure costs, affordable housing and developer obligations contributions required. Hence, allocating the additional 30 homes in BU033 will make currently-allocated BU032 easier to market and sell to a developer.

That said, we are actively engaging with the landowners on alternative options to possibly commence with individual self-build plots to "open up" the site. This route would require extensive works and costs to the owners to commence, hence the preference is to market to a developer, but either way we, along with the landowners, are very keen and intent on delivering this development site, including BU033.

The major positives of this site are that it's on a bus route, as near as can be to Mintlaw Primary School, and that the amenities at The Square are only a short walk away.
