

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

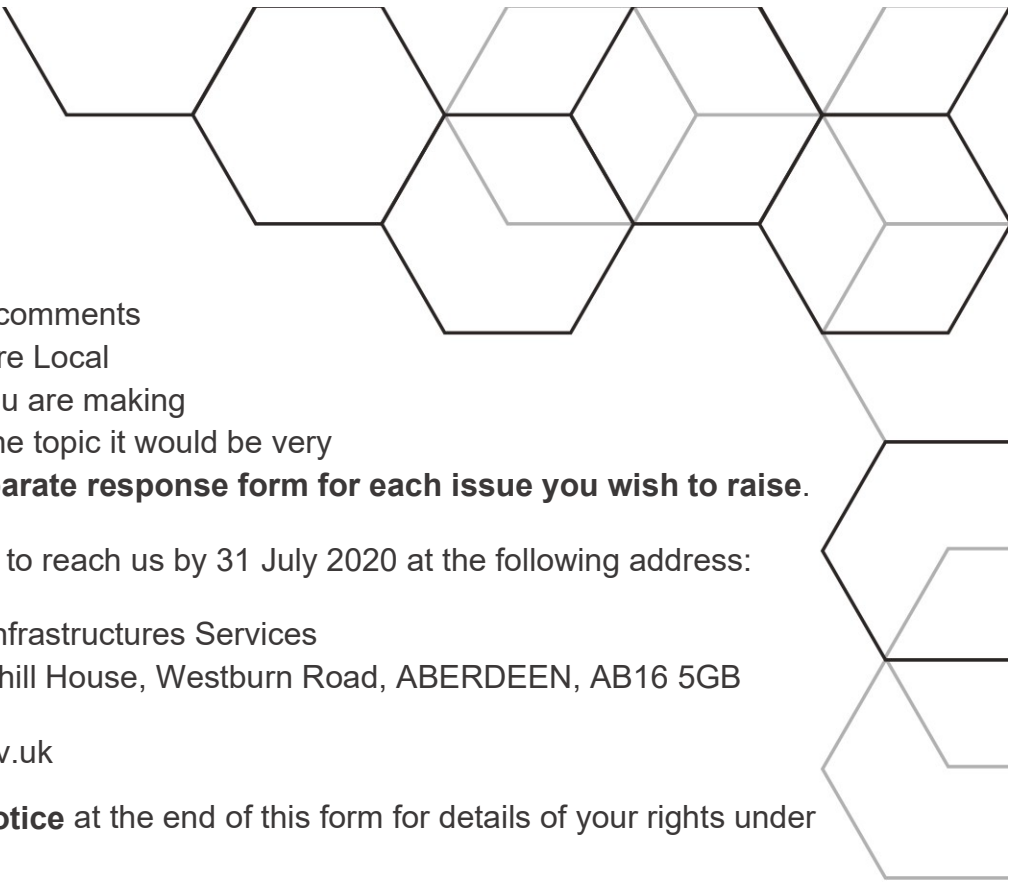

Reason for change:

I wish to make some comments on this addition to the LDP for Midmar. While the provision of suitable housing within the community is important, this particular plan appears to unnecessarily extend a previous plan which has never been completed. The area in question was to have 10 properties, and a green space, however only two of those properties are built, and have remained empty and unsold for over two years. It would seem much more appropriate to complete the 8 houses from the original plan (which will hopefully be suitably sized to be appealing), and retain the green space (Public Garden is I think the term used) between the new housing and the village hall.

We are all much more aware of the value of green space at the moment, and to plan it's removal/replacement seems counter intuitive.

The Hall garden itself is used for many functions during the year, with one of the appealing points being the situation and the view. Both would seriously suffer if the current Plan were to ever come to fruition. The Hall, it's functions and surroundings are key to the village community, so one would hope won't be compromised.
