

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Removal of Development Site OP2, WESTHILL from the proposed Local Development Plan 2020

Reason for change:

I wish to recommend the removal of Development site OP2, Westhill from the proposed Local Development Plan 2020 for the following reasons:

1. This site borders Mason Lodge which is a quiet rural community. The description details 38 homes and commercial/retail uses but no justification is given as to how these numbers were arrived at, Aberdeenshire Council is required to justify these number so the community understands the model and the demand, where is it?
2. The justification for commercial/retail uses is unfounded, there are large areas of commercial land on the city side of Westhill which are not developed nor in any likelihood about to be. Again, the Council is required to justify the demand for commercial land when many sites lie fallow due to low demand and a decreasing market
3. The 38 homes quoted are also speculative based on what demand? Is Aberdeen shire council ignorant of the continuing reducton of the North Sea Oil Industry which negatively impacts both the demand for commercial and domestic property?
4. Is Aberdeenshire Council aware of the 2016 OPITO UKCS Workforce Dynamics Report 2018-2035 which highlighting the decrease in oil industry employment of 80,000 jobs, and this was before the latest 2019 recession...!
5. There is little demand for additional housing within Westhill due to the continuing permanent downturn in the employment requirements of the North Sea oil industry. Reference OPITO UKCS Workforce Dynamics Report 2018-2035 which clearly states a reduction in the workforce of approximately 80,000 jobs, representing a 26% reduction, the majority of which will affect Aberdeen City and Aberdeenshire.
6. Focusing on Mason Lodge, why is the Council willing to demolish another rural community when oth opportunities lie within developed areas? Has the Planing Committee examined infill sits?
7. Based on the oppositionof the current Wethll OP1 Planning Application for a "Convenience Store" based in a residential development where **100% of the public comments were negative**, why is this not being heeded and listened to?
8. Would it not be better for the Planning Committee to consider infill sites rather than over-development of rural communities like Mason Lodge. Currently sheep

lie quietly in the Burland farm fields and the local community walk past this rural environment, the question we should be asking is why we wish to destroy this local rural setting?

9. Would the Council not be better planning for a "Westhill after Oil" a model based upon the probable shape of Westhill and Elrick once the UKCS recedes further as Oil Companies place their investment money in other countries with developing oil industries rather than the North Sea as a mature play? Is there any plan for our community after Oil? There is no sign so far!
10. Lastly, we are all aware that this site has been in the LDP for some time but, to date, no one has wanted to develop this area due to no demand, would it not be better to designate the land as rural or green belt and allow development as a community leisure area, here is little green space within the current Burnland development?
