

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

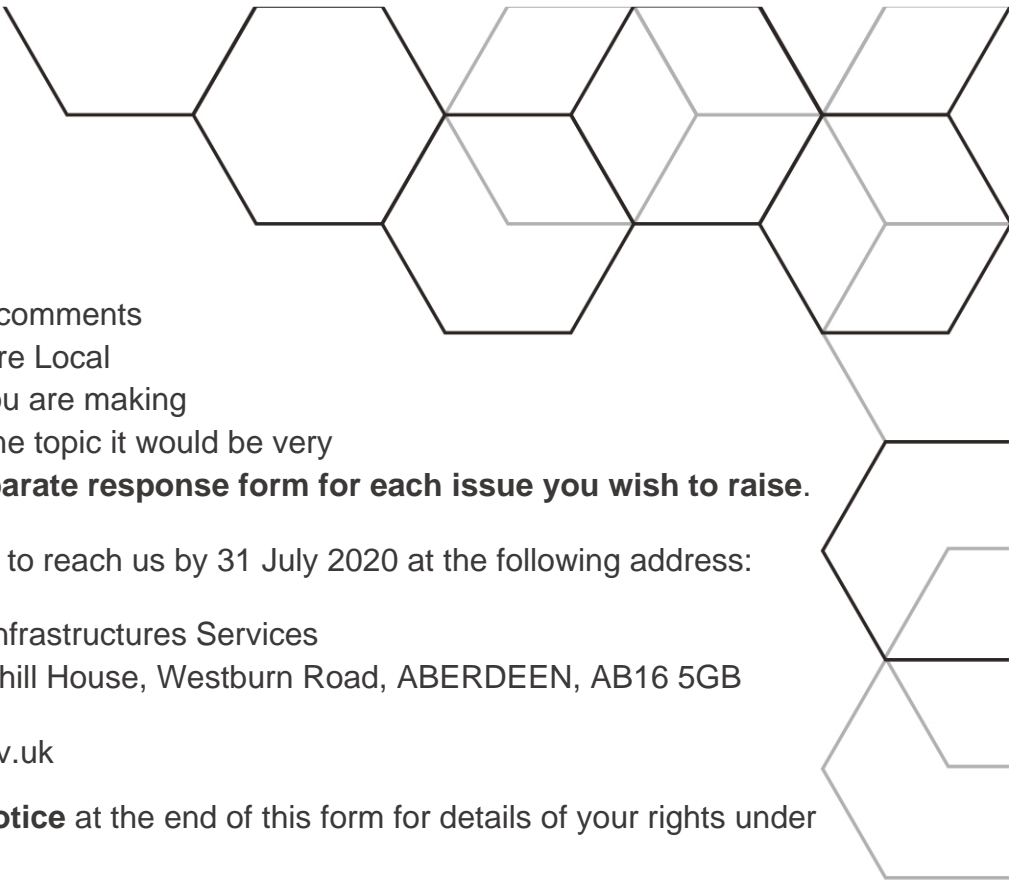

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Remove Site OP1, Echt from proposed LDP

Reason for change:

- 1) Drop in oil price posing threat of more loss of jobs and income in Aberdeenshire not conducive to property market and sale of housing.
- 2) Fragile economy in Covid climate means considerable increase in unemployment figures and reduction in activity of property market not conducive to sale of housing.
- 3) Multiple housing building already going on in Aberdeen and Aberdeenshire and house builders unable to sell new properties despite incentivising purchase. Currently there is new housing available locally (in Dunecht) that is not selling – why is there need for more?
- 4) Concern that building may start and need to stop due to repeated wave(s) of Covid and increased lockdown restrictions.
- 5) High risk in reducing value of current homes in Echt; in last few months several people in the community have struggled to sell their properties. There has been a notable drop in value of properties in Echt since new homes were built here in 2015/6.
- 6) Concern regarding loss of habitat for local wildlife species.
- 7) Noise and disruption to Echt residents and local wildlife during building works.
- 8) Piecemeal manner of proposals and lack of communication and foresight regarding extent of new housing planned in Echt. Should have been greater transparency in 2012 LPD relating to long-term plans for the village.
- 9) Lack of local infrastructure to support 25 new homes/families including;
 - Very limited public transport service to Echt resulting in reliance on cars
 - Lack of parking facilities causing lots of vehicles to be street parked particularly near housing and the primary school posing risk of accident/harm.
 - Capacity of primary school in Echt and high school in catchment area to accommodate increase in number of children requiring schooling in local area.
 - Scottish Water have advised that the waste water treatment centre in Echt may not support 25 new homes.
 - Query sufficient local recycling facilities for 25 new homes?
 - Lack of community facilities and sports and recreation facilities and ability to access these (without dependence on cars) within the local area if 25 new homes built.
