As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Roads & Traffic Issues

Reason for change:

The classification of roads in the areas of the proposed redevelopment at **OP1 and OP2** is **C Class.** These roads simply cannot handle the increase in traffic that will arise from this development.

Any potential widening of these roads whilst improving access for the planned OP1/OP2 development will also cause an increase not just of the volume of traffic in the development area (what, 200-300 additional vehicles to contend with?) but an increase of traffic coming off the B999 using the improved road as a rat-run that will then come from the B999 through the narrow village roads along Panmure Gardens and Manse Road onto either the main A90/A92 dual carriageway or AWPR and, of course, in the opposite direction as well.

There will also be an increase of the size of the vehicles (HGV's etc) using the route as currently larger vehicles struggle to get through the C Class roads and tend to avoid the narrow roads and sharp bends if possible.

Overall, an increase of traffic volume and size will be detrimental to the village and pose a substantial health and safety risk to residents let alone quality of life due to noise and disturbance. A widening of the roads to facilitate the increased traffic will spilt Potterton in two requiring residents to cross busy roads to get to the other side to visit friends, bus stops, shops etc. with no proposals by the Developer to address these issues.

The Council trumpeted the benefits of the AWPR, traffic channelled away from Aberdeen, less traffic on morning commutes, shorter drive times etc but Potterton now appears to be on the verge of having MORE traffic to contend with. The settlement will be dangerously busy with massively increased cars numbers from this one Development alone and heralding the return of the infamous traffic choke-point at the Parkway leading into Aberdeen. We appear to be not only about to lose the much-touted AWPR benefits but actually make car travel substantially worse than it was pre-AWPR!

On that basis, the LDP for OP1 and OP2 Potterton should not be implemented.
