

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

**Protection of Ancient Woods to the north-east of OP1**

## Reason for change:

These ancient woods have been encompassed in the "green-space" or open-space of OP1, no statement has been provided on the provision of their protection.

These woods cannot simply be left open for people to traipse through, use as a play area or dumping ground. Ancient woods are protected and require to be undisturbed for the most part, they can be massively impacted by nearby developments, incorporating the wood into the open-space of the development will simply result in their eventual destruction.

Ancient woodland, ancient trees and veteran trees are irreplaceable. I do not see that the developer has made any attempt to propose any action to avoid negative effects on the ancient woodland. This inaction will result in their total loss.

Given the proximity of the development to the ancient woods, the developer may simply have no option but to reduce the scale of development or simply chose an alternative site.

The Council themselves have recently criticised Aberdeen Council for their lack of protection of ancient woods on Green Belt at a development site at Leggart Brae, near the border of the two council areas, requesting that "the site is removed from the LDP over what it describes as the "unnecessary loss of green belt land". will they not similarly voice their concerns over ancient wood/green belt loss within their own Council area?

On this basis, the development of OP1 should not be implemented due to the potential loss of ancient woods on Green belt land. Should this not happen, the developer must propose better protection for the ancient forest that avoids inclusion in the open-space for the development and provides for more distance between the development and the ancient woods and better protection of the ancient woods themselves from human disturbance.
