

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

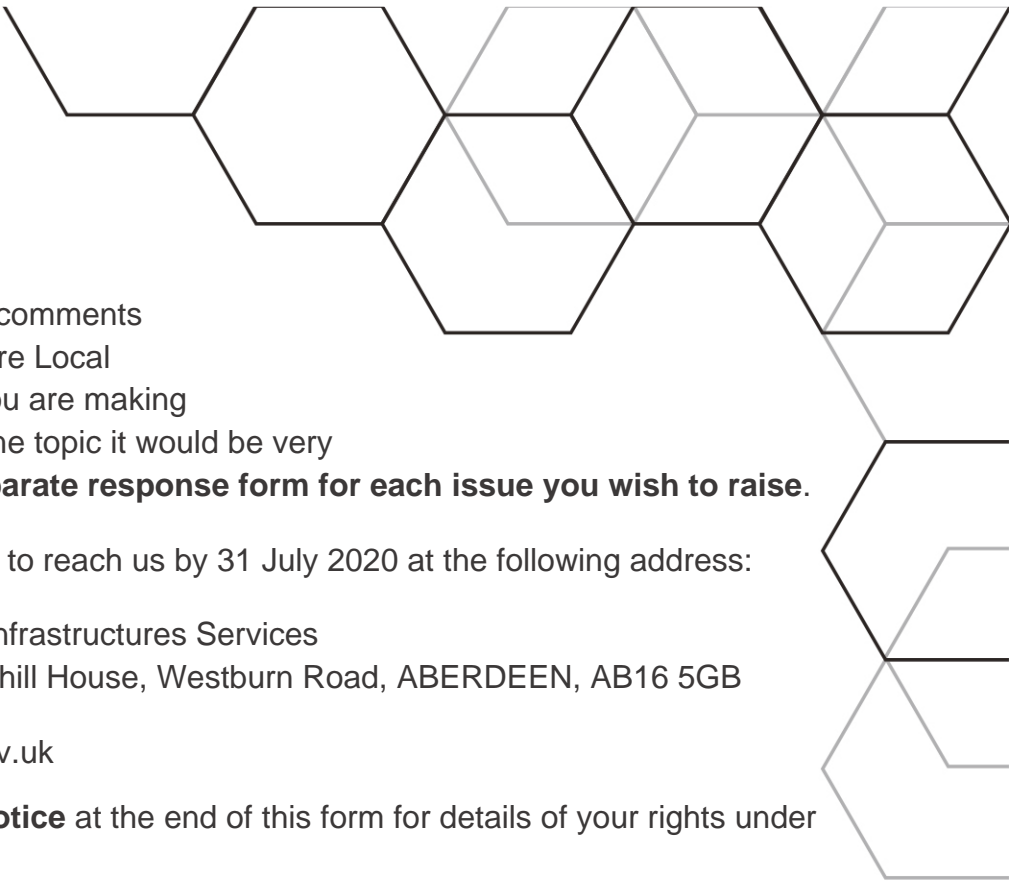

Housing issues and facilities & services

Reason for change:

I understand that the Developer intends building two storey houses on OP1. There are very, very few two storey houses in Potterton. The recent development houses at Panmure Way are two storey but of the remainder of the settlement, only perhaps a dozen or so are of that type.

This large development of two storey houses will obviously cause a dramatic loss of view from the existing houses as well as appearing very odd compared to single level housing in the existing parts of Potterton affected.

The Developer argues that Potterton needs development, not so, we are quite happy the way we are thank you very much! There are already many massive developments taking place or planned to take place near Potterton, these are at Murcar, Blackdog, the Trump estate and the massive Energetica Corridor as a few examples. Whilst some of these may be within another Council area, Potterton will directly feel their impact in many ways, vastly increased traffic for one. I doubt very much that Potterton or anybody else needs more housing in this area, quite the opposite.

Where are all these new buyers coming from given the massive downturn due to Covid-19? The oil crisis of a few years ago and its continuing impact mean the Aberdeen area no longer has the high numbers of potential buyers of new builds it once had, add in the ongoing Covid-19 issues and the market is almost non-existent. The next few years will be about recession and belt-tightening not splurging money buying new build houses.

Facilities are non-existent at Potterton, we like it like that, an excellent corner-shop come Post Office, friendly pub, that's all we really need, perhaps a few smaller shop units in the near future. It's a quiet small settlement, it must stay that way. If we need something more we'll ask for it.

On these bases, the development of OP1 should not be implemented, it will cause more problems than it proports to address, the benefits the Developer portrays are in fact negatives and the expansion of Potterton is not simply needed, not asked for and not necessary.
