

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Newburgh settlement vision – development to the west and 'western bypass'.

Newburgh allocation OP1. Paragraph 1 (link road between B9000 and A975)

Newburgh allocation OP2. Paragraph 1 (link to potential future link road)

Newburgh allocation OP3. Paragraph 1 (education investment); Paragraph 2 (distributor road)

Newburgh settlement plan. Allocation OP 2 and possible future link road

Reason for change:

I would agree with the need for any new development in Newburgh to be at the western edge, both to try and avoid additional traffic going along Main Street and to have easier access to the AWPR.

I welcome the notion of a 'western by-pass'. However in order to ensure this can come forward, in order to reduce impact on Main Street, the settlement statement, as well as allocations, need to align and be clear on how the by-pass can be delivered.

The OP sites noted all refer to the linkages between the B9000 and the A975. OP1 is already developed in terms of the residential part with the business section remaining undeveloped. I am unclear how this can help facilitate any 'by-pass' unless there is a joined-up approach with other developers and landowners - specifically with the developers of OP3.

I understand that the 'by-pass' is shown indicatively on the settlement map but if there is a real drive from local residents and the Council then this needs to be set more in stone. The real opportunity, in my view, comes with OP3 to start the process. Rather than an indicative line on a plan, the line should be clearly marked as being through site OP3.

However, with OP2 already being developed I'm not sure how that site will connect into the 'by-pass'. Although the original Masterplan and approved site layout plan make reference to potential linkages to the west (outwith the site), unless there is agreement with the Council/ Developer and landowner and this comes forward through a separate planning application, there is no way of ensuring the linkages. And this can also be said about the remainder of the 'by-pass' to the north.

The reality is that the only way of ensuring that the 'by-pass' comes forward is by mass allocation of housing/ business land to the west/ north of Newburgh and making it a pre-requisite for a joint Development Framework/ Masterplan to deal with this. Otherwise, I would suggest it is merely a pipedream which is unlikely to come to fruition and that being the case, the development of 160 homes is going to have a detrimental impact on the village, less so traffic going through Main Street but more so on education provision.

On the latter, the school, whilst it does have some limited capacity internally to take on some additional children, it does struggle in terms of space externally to extend as the site is constrained and with the potential for c. 60 new pupils coming from 160 homes, I don't know where the new space would come from. There is a playing field adjacent but to use that for buildings would remove a valued and well-used piece of open space. In that respect perhaps the correct thing to do would be to include a new school within the OP3 allocation because otherwise I'm not sure how any 'substantial investment in education facilities' would make a marked improvement in the current school.
