

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

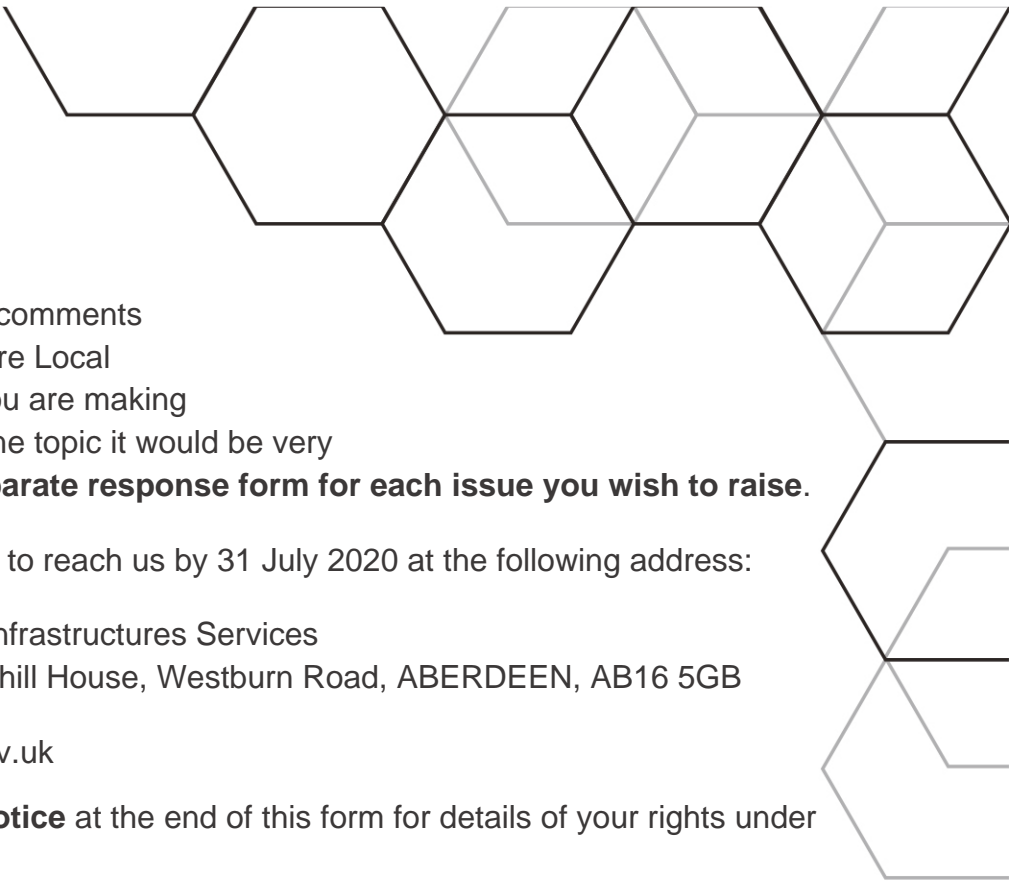

Vision - Remove "contemporary" from 2nd sentence

Reason for change:

The LDP describes Potterton as being "contemporary" which could be inappropriately portrayed as a reason for possible development.

Potterton is very much a rural community. Previous LDP's have correctly identified the settlement as such. It is a small place, surrounded by long-established farmland and is within the Green Belt.

"Contemporary" makes it sound as if it is an up-and-coming location ripe for further development. It is most definitely not.

The LDP looks to fill our Green Belt with 2 storey houses which are totally out of character for the settlement and will irrevocably ruin the look and feel of the existing village, the vast majority of which consists mainly of 1 storey housing.

Contemporary is being deliberately used to describe the village as something it is not and never has been.

I request that, on the above basis that the word "Contemporary" be removed from the Potterton Vision statement.
