

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020

RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.


Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Laurencekirk Appendix 7E p692 Reserved Land

The Addition of an R4.

A site to be reserved for a "Park and Choose" close to the planned Grade Separated Junction in the vicinity of the A90 and A937 Junction.

Reason for change:

The fastest buses between Aberdeen and Glasgow take under 3 hours for the journey. The shortest time for the journey by bus from Laurencekirk to Glasgow is over 4 hours even though the journey length is 30 miles shorter and the fast buses from Aberdeen to Glasgow travel via the A90 within 600m of Laurencekirk Town Centre.

Service providers wish to maintain fast journey times as they are popular with customers but visiting town centres slows their progress. Therefore very few buses directly serving Glasgow and Edinburgh stop in the Kincardine and Mearns Area.

A "Park and Choose" similar to the facility at Newtonhill at the location suggested would enable fast long-distance buses to serve Laurencekirk with minimum stopping time. A similar operation already exists at Broxden serving Perth. The proposed facility would integrate Laurencekirk into the larger bus network and increase the demand for feeder services which would in turn improve the local rural public transport viability.

The likely introduction of automated driverless public transport vehicles within 10 to 15 years may enable the provision of an automated town shuttle service between the proposed "Park and Choose" and the Laurencekirk environs.

If future innovations in public transport are to be exploited for maximum community benefit suitable interchange facilities similar to the one proposed will be a necessity.

Transport Action Kincardineshire has the support of the Community Councils of Kincardine and Mearns.
