

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



**R1 Reserved for Park and Ride and Out of City Bus Station.**

## **Reason for change:**

The Guild Street Bus Station in Aberdeen is often overcrowded and confusing, lacks decent waiting facilities and is not popular with users. [REDACTED]

[REDACTED] A schedule manager of Stagecoach told a TRAK meeting that access for the buses costs the equivalent of a bus on each route using it. Therefore any initiative to reduce the Bus Station traffic has to be welcomed.

A Bus Station at the suggested site would enable buses to terminate outside the City with passengers being able to use the transport servicing the Park and Ride for onward access to City destinations. At Guild Street they usually have to leave the shelter of the bus station to access other services.

The proposed facility would also enable routes from the South going to the North of Aberdeen the option of discharging passengers for Aberdeen and then continuing North via the AWPR to their destinations without having to pass through the City. This will improve the journey times to Ellon Peterhead and Fraserburgh from the South.

The Guild Street Bus Station is leased to a sole supplier [REDACTED] Competing bus companies negotiate with them to use the facility. A publicly owned out of City bus station will allow bus companies to use it on equal terms and will encourage competition. Bus passengers would change between different bus companies' vehicles within the bus station and hopefully be able to wait between connections in pleasant conditions.

Transport Action Kincardineshire has the support of the Community Councils of Kincardine and Mearns.

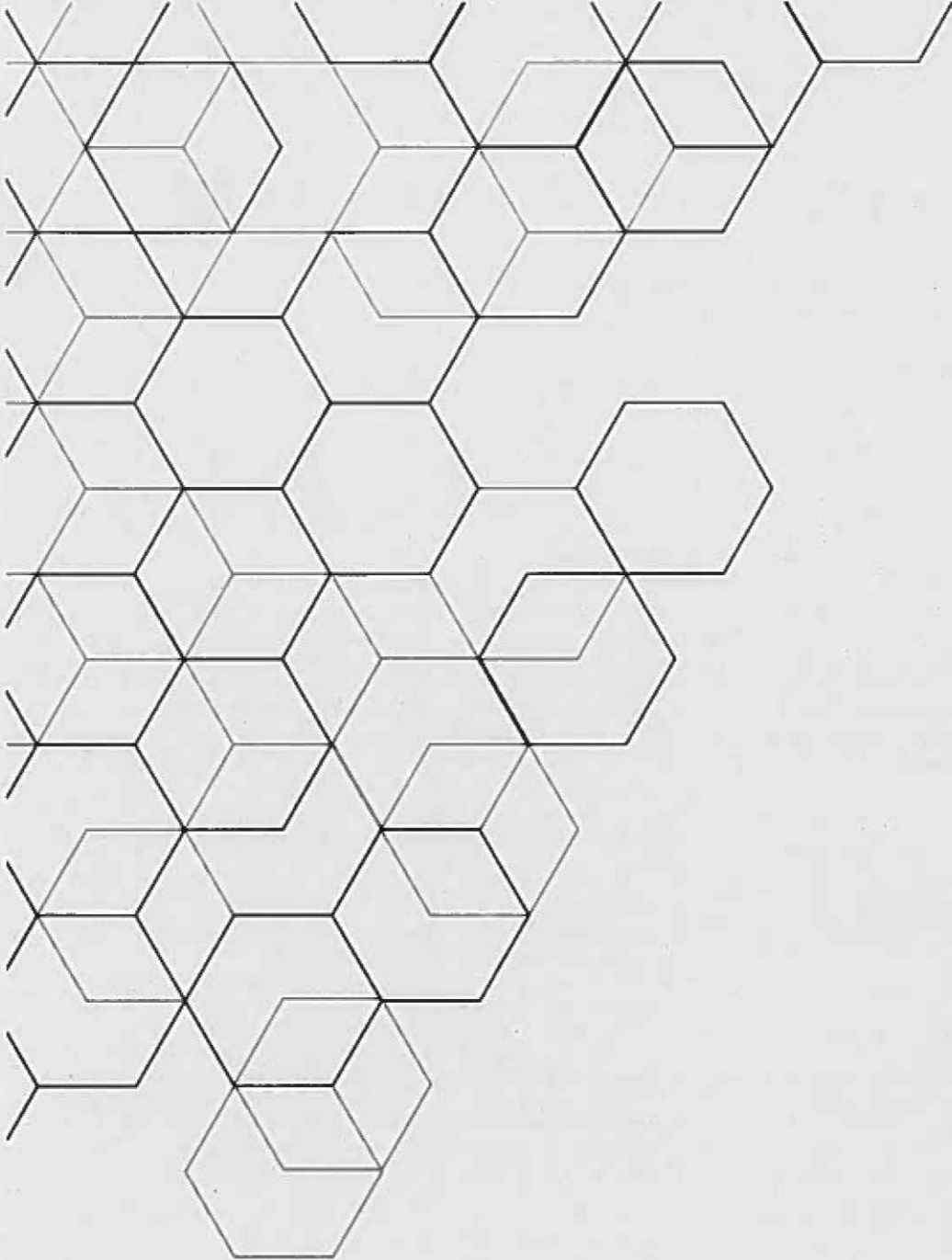
