

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Appendix 7E Page 745 Stonehaven Reserved Land

The addition of an R2.

A Site to be reserved close to the roundabout at the junction of the A90 and the B979 for a "Park and Choose" Facility.

Reason for change:

A "Park and Choose" at the proposed location similar to the facility at Newtonhill will enable fast long-distance buses to serve Stonehaven and connected destinations with minimum stopping time. Most bus travellers prefer short journey times and visiting town centres is not feasible for fast services. Short journey times can be achieved with bus stops permitting safe swift access from trunk roads.

Transport Action Kincardine (TRAK) attendees were informed by a senior representative of Stagecoach North Scotland that in his view an opportunity had been missed with the AWPR project as a Park and Ride at the location suggested would be a useful Interchange. He reported that such a facility exists at Broxton serving Perth and it is used by the Megabus service.

The proposed location will be served by the 747 Airport Bus Service and further linked to Stonehaven with a town service visiting the under-construction 230 house Ury Estate. It could also be used by the existing X7 and other coastal services.

The 747 service will allow bus passengers from North and West of Aberdeen the opportunity of using the proposed "Park and Choose" facility rather than the overcrowded Guild Street Bus Station in Aberdeen. These passengers will also be able to more accurately judge their journey times to their choice of interchange as they will not be subject to the vicissitudes of the Aberdeen City traffic.

Motorists will be able to join the fast bus services via the AWPR therefore not adding to the Aberdeen City traffic congestion and pollution.

Within the next 10 to 15 years automated bus transport will probably be introduced. If a fully integrated transport system is to be developed interchanges similar to the one suggested will be an imperative.

Transport Action Kincardineshire is supported by the Community Councils of Kincardine and Mearns.

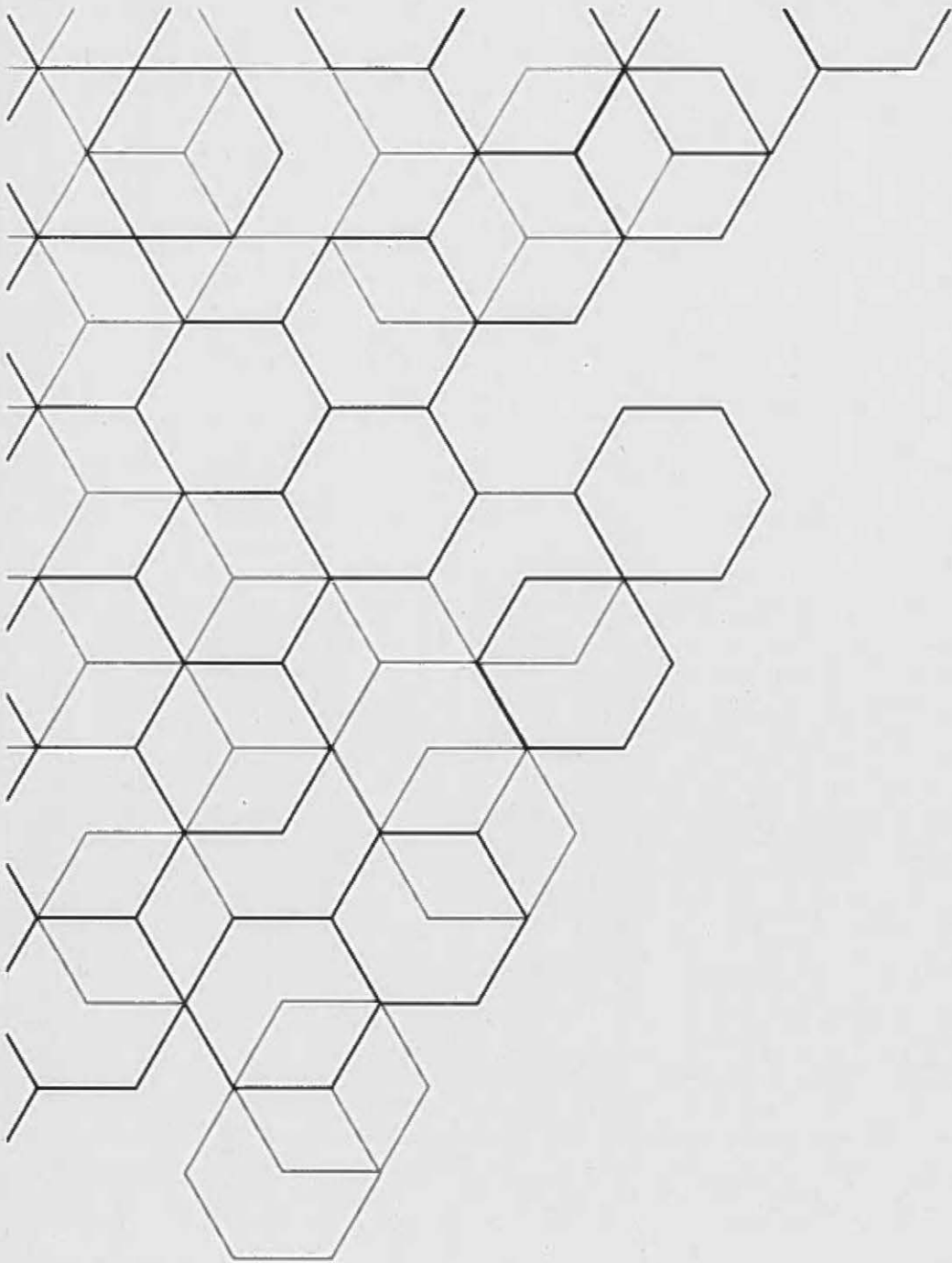
Aberdeenshire Council will only keep your personal
