

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

## Reason for change:

I wish to request the removal of the area OPI – Land south of Earnsheugh Terrace from the Local Development plan because the land is not in a suitable location for the building of homes.

I request this for the following reasons:

1. The access road is too narrow for the development  
Any road constructed could not fulfil the rules for adoption as detailed by Aberdeenshire Council in their document "Standards for road construction consent and adoption". Detailed table 24.1 requires a carriageway width of 5.5m and footways of 2m on both sides  
The document "Strategic Environmental Assessment " for this area states that the road is not wide enough to support development.
2. The village of Findon has no public transport provision and is unlikely to get a service in the future. A weekly bus service was discontinued several years ago.
3. The village of Findon has no footpath or cycleway links to local amenities which are all provided in Portlethen. The road to Portlethen is a narrow single carriageway with no official passing places, no footpath and no street lighting.

These issues mean that the area does not fulfil Aberdeenshire Council's criteria for an area suitable for development. (Ref. Local Development Plan section 14, RD1.3 and RD1.6)
