

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Please remove the privately owned field stretching along the eastern boundry of R1 from the plan and the designation as ‘reserved land’.

**Reason for change:**

This section of land, lies to the east of Newmachar Football pitch and has a boundry fence. It is a privately owned agricultural field adjoining the owner's house. This field is currently rented by the owner on an annual basis to Newmachar Football Club to allow its use as an informal additional practice area. Prior to this it was used for animal grazing.

The designation of this privately owned field as a recreational area may be an error, under the assumption that it is part of Newmachar Football Club pitches.

The 2020 plan and the Corsduick Road, Newmachar Masterplan, includes a proposal for new adjoining football pitches in addition to the current pitch. This may mean that the private field would no longer be useful to Newmachar Football Club. The owner may require to use the field as previously for agricultural purposes. It therefore should not be included in R1 designated for the development of a recreational area.
