

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

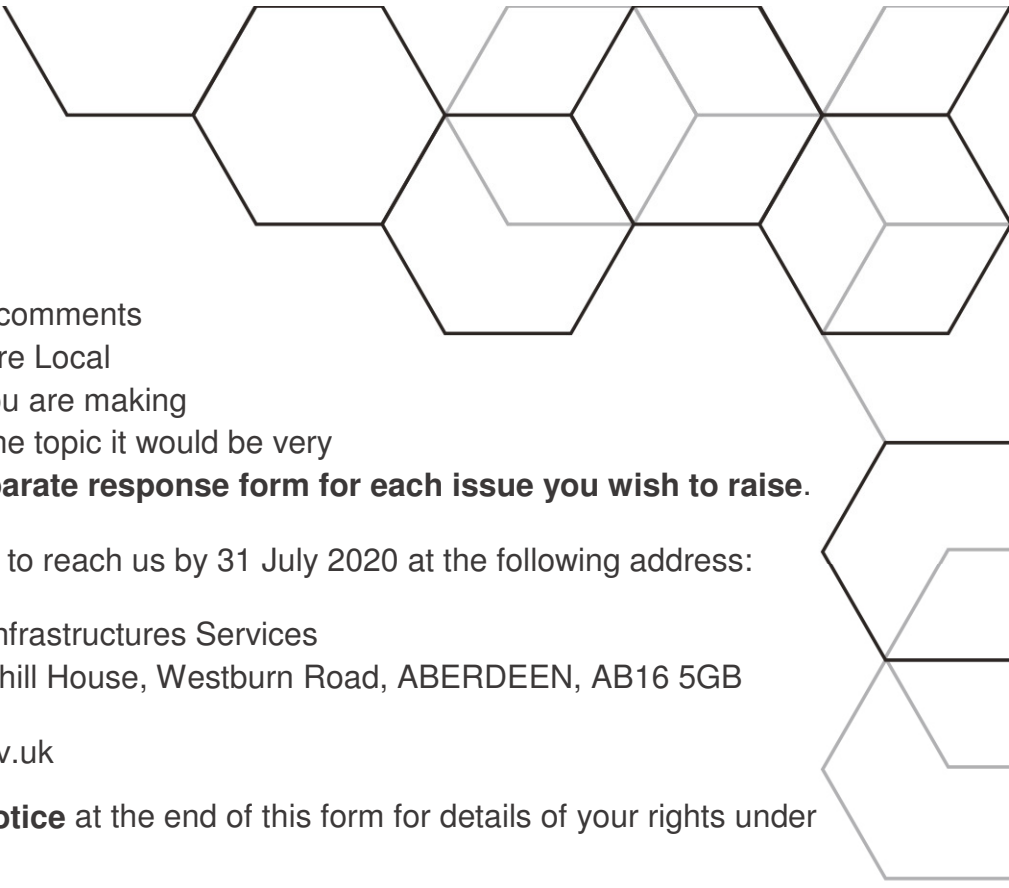

YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. We will publish your name as the author of the comment, but will not make your address public.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Remove or amend Policy PR1 (pg. 73) "Protecting Important Resources" to acknowledge that the mapping on the Ancient Woodland Inventory is "provisional" and "not definitive" and should "be used with care".

Remove the Ancient Woodland designation from the Mapping at pg. 78 of the LDP.

Reason for change:

The SNH Guidance on Ancient Woodland Inventory states a number of things which are worthwhile considering, as follows;

- Ancient Woodland comprises land that is *"currently wooded and has been continuously wooded, at least since 1750"*;
- There is *"no legislation specifically protecting ancient woodland"* but, despite this, SNH will seek to use the planning system to protect ancient woodland.
- The mapping shows the location of *"many"* of our most valuable woodlands (but not all).
- The inventory is a *"provisional guide to the location of Ancient Woodland"*.
- The inventory is *"not definitive"* and should be *"used with care"*.

This does not strike us as providing a sufficiently accurate or concise base on which to include this in the LDP. Until such time as the certainty required to include the mapping in the LDP, this should be left out of the plan to help deliver the certainty required from an LDP.

From our experience of the Council applying protection to sites featuring on the inventory, there does not appear to have been the care applied to take account of the provisional, incomplete, potentially inaccurate, and not definitive nature of the inventory and until there is further certainty, if this is not removed from the plan, this needs to be acknowledged in the Policy, otherwise blanket application of the policy will follow.

The Council have historically resisted identifying the SEPA Indicative Flood Map on the Proposals Map on the basis that the mapping is not theirs, could change in-between LDPs, and this would result in confusion. We do not see why this would be any different (particularly given the significant uncertainties highlighted about the mapping).
