

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

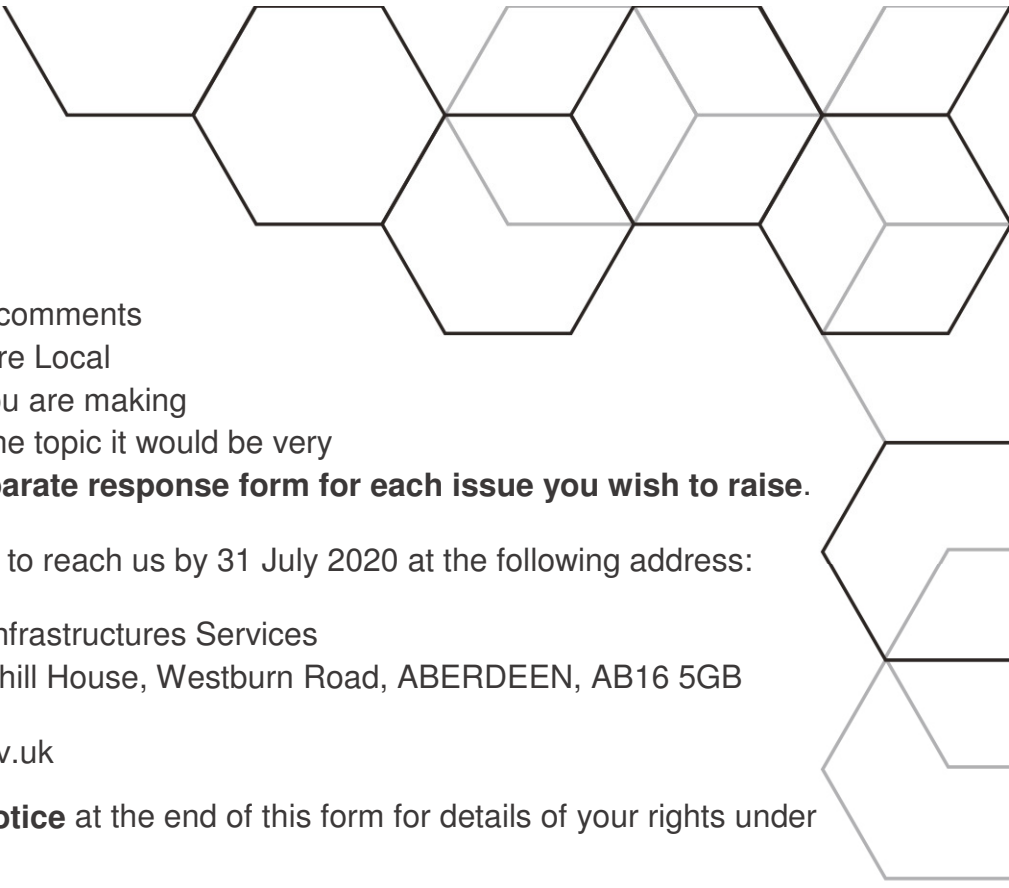

Update Policy PR2 (pg76) and include a Map as an Appendix to show the routes of the "closed railways" which will be protected under the Policy, for the avoidance of doubt.

Reason for change:

Whilst we support the thrust of this policy and its intent, and are supportive of the inclusion within its scope of disused railway lines, we believe that it would be beneficial to identify these on the Proposals Map (for the avoidance of doubt, and to provide users of the planning system confidence and certainty). This is in line with the desire for map based LDP's.

The reinstatement of new local/rural railway services elsewhere in Scotland has been extremely successful and we believe the reintroduction of, in particular the Kintore to Alford line (track bed largely intact), such services in Aberdeenshire could bring significant benefits in terms of the sustainability of rural communities and future development within them.

This would also serve to reduce the pressure on the Aberdeen Green Belt by providing attractive alternatives to car based commuting (potentially taking as many as 20,000 car movements per day), and potentially take significant freight movements (potentially 4,000 tonnes of freight per day) off the local road network with associated carbon saving, reduction in congestion and wear and tear on the network.

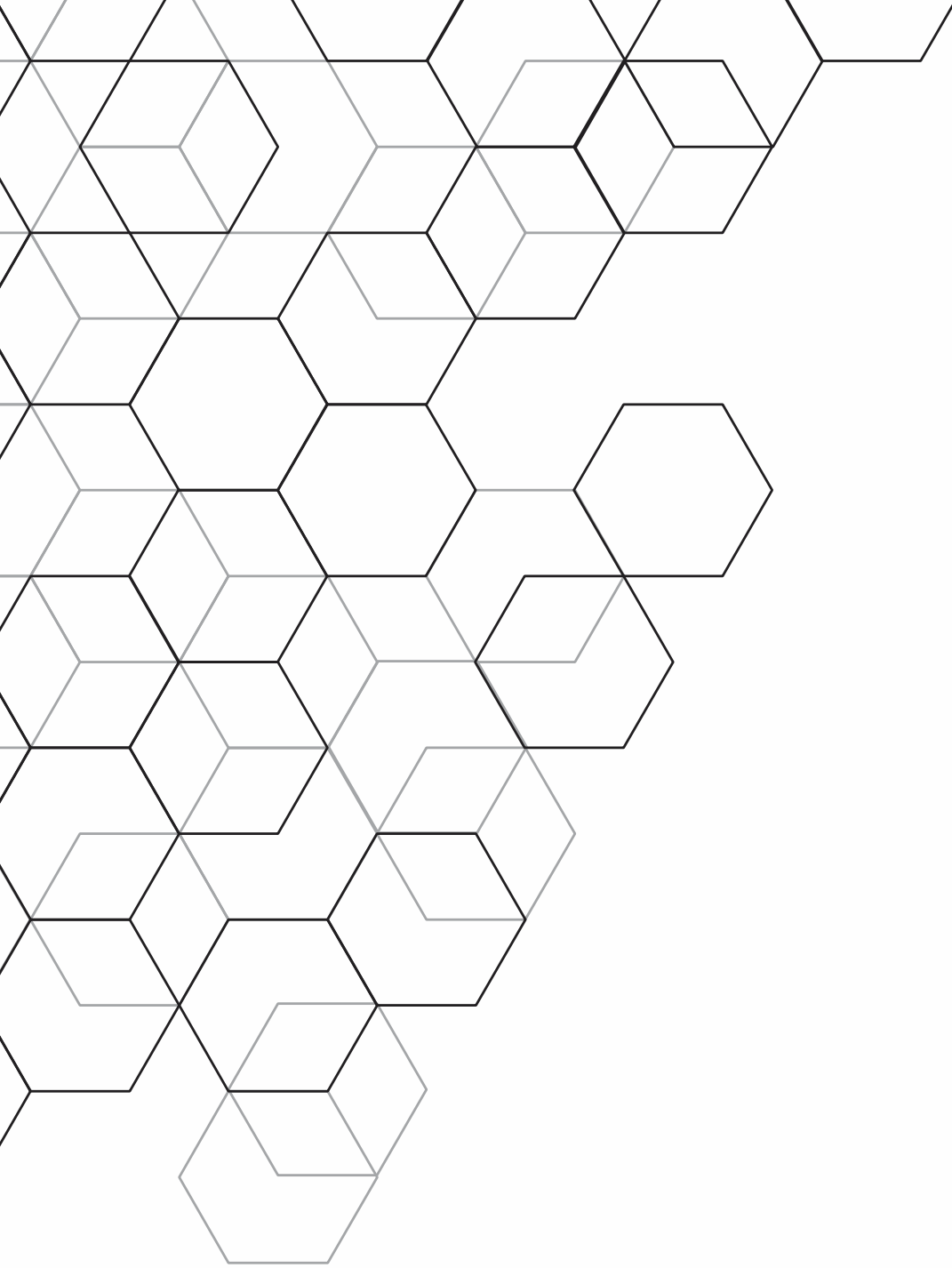

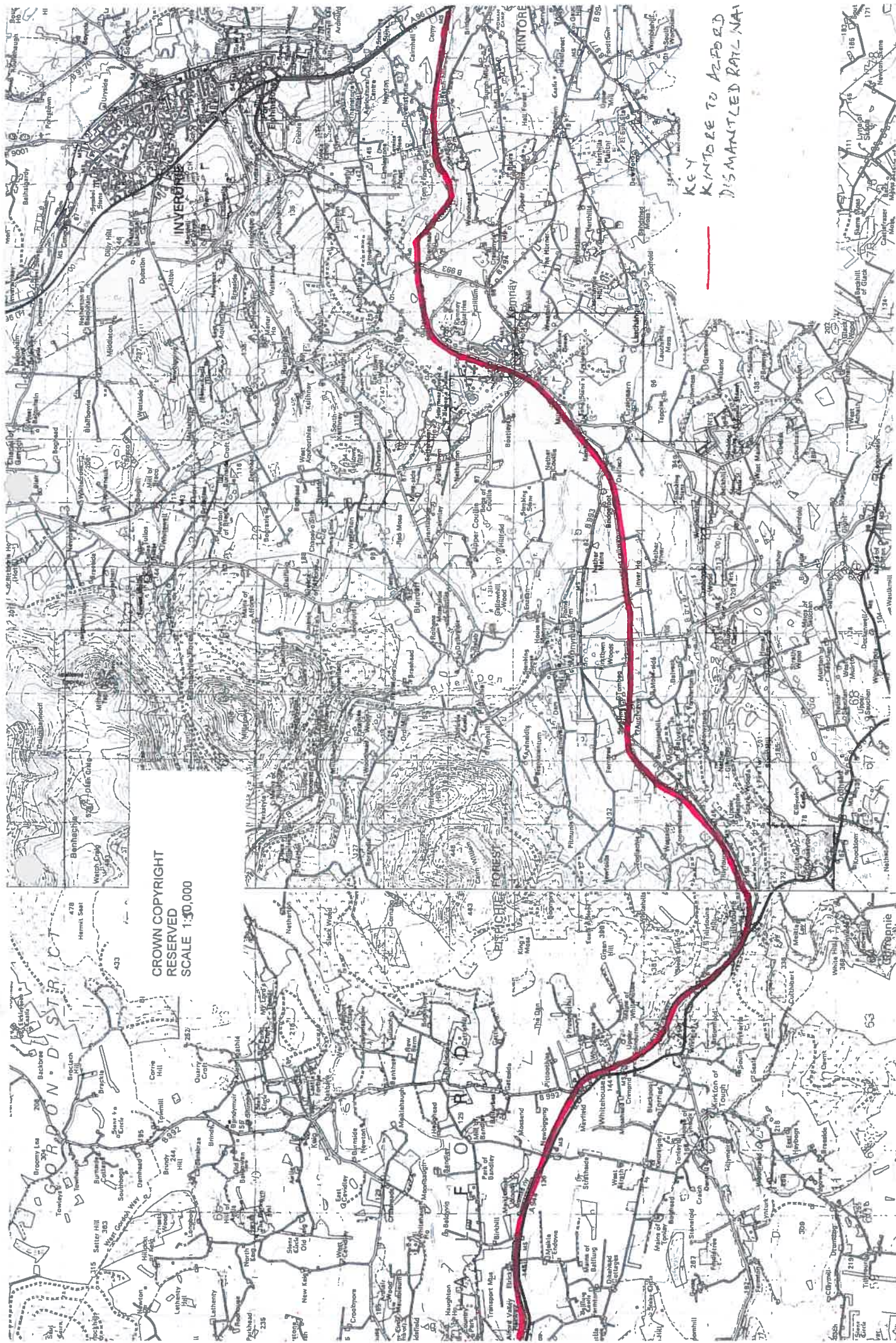
