

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Reason for change:

450 Homes, 10HA Employment Land were agreed by Planning Service and Area Committee in December 2016 after considerable discussions with Planning Service. Current negotiations with Developers are based on the approved masterplan, therefore we see no reason to revisit an agreed layout which satisfied Planning as well as the Roads Service and the requirement to revisit the masterplan process should be removed, so as not to discourage potential developers who are interested in the site at present.

At the request of the Planning Service the Community facilities were removed from the agreed masterplan along with possible/future additional Primary School, therefore the reference to Community Facilities should also be removed from description of development as the planning service have determined that these are not required on this allocation.

The masterplan covers retention of the ancient woodlands as much as is possible and masterplan was designed to protect the existing watercourses within the ancient woodland, therefore we do not see why this needs to be revisited either again extensive discussions were undertaken with the planning service to determine their requirements thru the approved masterplan process.

Having discussed with Council's Archeologists during the masterplan process we were assured that this structure (stone cairn) was outwith the OP1 site and as such would not have to be investigated, therefore we suggest this paragraph should also be removed.

We support the inclusion of OP1 within the LDP 2020, however we feel that the changes above will allow the current discussions with developers to continue without future obstructions affecting the potential overall delivery of the developments.
