

RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

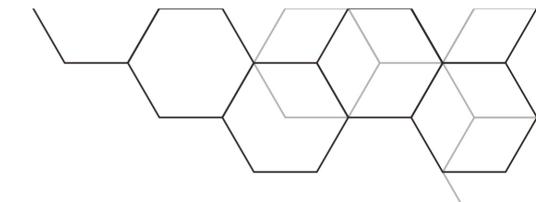
Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



R1 (For Replacement Cemetery)

Reason for change:

The Settlement Boundary is not shown round the area R1, we would suggest that this area of ground be taken within the proposed settlement boundary.

The area of ground for a new Cemetery has been agreed with Local Authority and only covers 1.89HA of the reserved ground R1, therefore definition of R1 should not restrict future development on remainder of R1 to Cemetery as it is large enough to accommodate, for example, a Crematorium or Community Facilities such as a Sports field and should also allow the pattern of individually designed houses such as Wellfield & Lingasound to be extended along the roadside to assist in the screening of the new Cemetery from the finished Markethill primary school R2.

We do not see any benefit to the Community by restricting the R1 allocation solely to Cemetery use, a broader description to its potential uses should be incorporated within the LDP to allow further development around the Cemetery in various use classes.
