

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

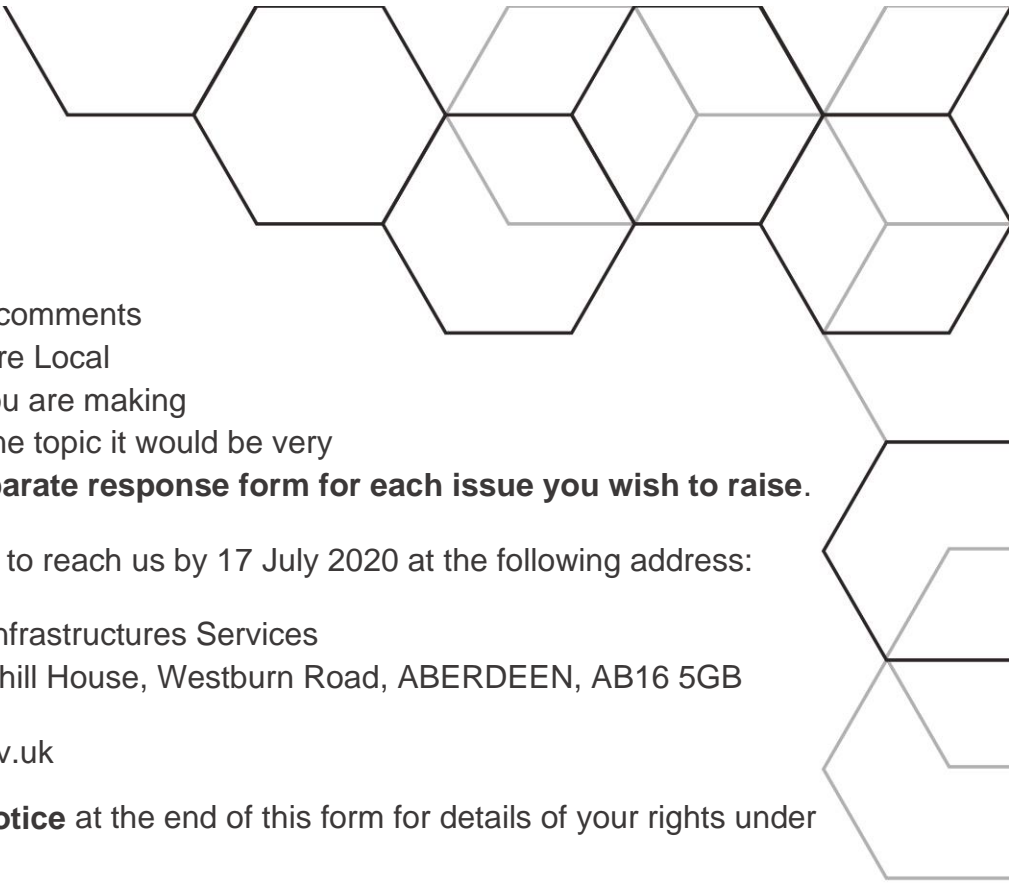

## Reason for change:

BUS 2 - Should be removed from LDP as it is currently occupied by an established business ( ), therefore this allocation has already been taken.

BUS1 - Should incorporate Area OP4 (2017 LPD) so as to allow connectivity into the new / proposed OP4(2020LPD), a masterplan requirement for this site alone is prohibitive to development and this requirement would be better removed to encourage development.

BUS3 (2017 LPD) - The settlement boundary should be re-aligned to take this area back within the defined settlement and should be allocated as an OP or business site given its prominence to the A947 as well as its topography which would allow its ease of development for numerous use class or mixed development opportunities.

Its proximity to the preferred access to OP1 would also support its inclusion within the 2020 LDP as well as within the defined settlement boundary of Turriff.

Although this site has not come thru with a planning application recently significant work has been undertaken with developers and is currently with a number of prospective developers due to its unique location on the A947.

We therefore request that this area of ground be incorporated within the finalised settlement boundary for Turriff in the Aberdeenshire LDP 2020.
