

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

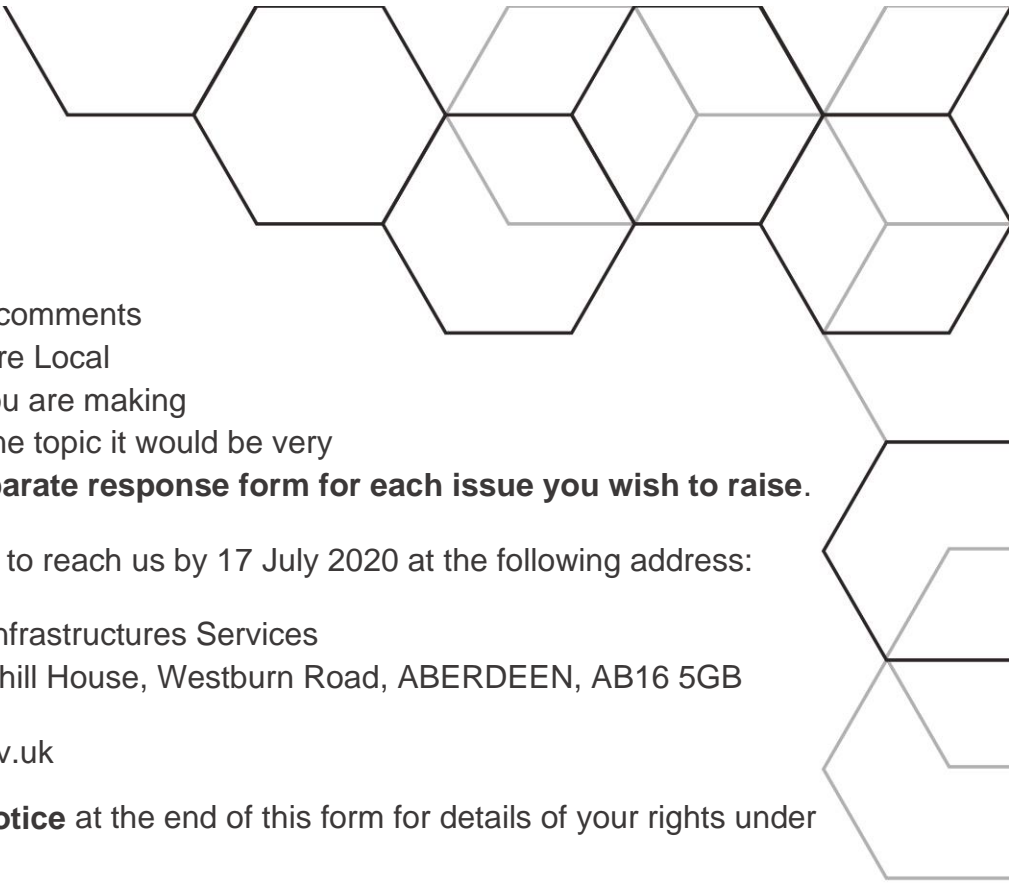

Appendix 7a Settlement Statement – Banff & Buchan

Reason for change:

BOGTON Should be included within the Settlement Statement for Banff & Buchan, due to development over the last 5–10 years. Bogton as a settlement is now similar sized to for example : - Crudie

Expansion to Bogton and especially the recently established Carnousie Avenue cannot be promoted through the current LDP as it is not a defined Settlement, therefore it would have to be assessed under R2.11 – 2.17 Organic growth of Settlements this restricts the future development of Bogton to 20% of Identified Settlements.

However the area is currently identified as Bogton/Forglen within the defined settlements of the LDP and covers numerous square miles, it does not currently have a boundary round the settlement which makes it difficult to identify a policy which works for this area. On investigation Forglen is the wider area of countryside with Bogton clearly being the defined settlement to anybody who visits the area with a mixture of houses whether it be on the original Bogton Row or the newly formed Carnousie Avenue.

Therefore we suggest that Bogton be urgently included as a defined settlement with a defined boundary being drawn up around Bogton with additional ground allocated within its boundary for further development, especially in the newly established Carnousie Avenue area.
