PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Vision for Laurencekirk

Reason for change:

In general terms the statement is acceptable. We feel that the issue of traffic and parking in the town, particularly the High Street, needs to be amplified as we believe this should determine the priority in the terms of planning bids.

It is noted that the dedicated route for a relief road has now been dropped from the LDP and an alternative is required.

Therefore, we believe that priority be given to the planning bids at Beatie Lodge, the field to the east of the primary school. The reasoning is that any new road infrastructure could be designed to provide a link between Garvock Street, Frain Drive/Johnston Avenue and the OP6 site thus providing a partial relief road running parallel to the High Street.

This would also allow the potential to being extended to link up with OP8 and from there to the Community Campus.
