

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

OP7: Land west of Fordoun Road

Reason for change:

The statement in the planning overview is confusing regarding the number of houses being proposed.

Original planning bed was for 42 units excluding the 7 number that are under construction

Plots 8 to 13 inclusive await planning approval yet the allocation states 15 number

Are we to assume the development per the planning officers assessment is for a total of 28 units?

It is noted that this site when called KM066 in the 2016 Main Issues report was put forward that the planning officers preferred option was for 100 residential units on this site

The overview stated the site has good access for the railway station and bus services

The site would fit in with the existing settlement and would have minimal visual impact

There are existing allocations for 1105 houses which have yet to come forward therefore there is no need for this site at present.

However, if a site were required, this site would be a suitable option

This is now 2020 and there has been no construction on the OP1 site or the OP3 site despite the Scottish Government committing to a new grade separated junction

As previously stated with the OP2 site ending and to maintain a house building programme within the town we have here a Shuffle Ready site along with a strong demand.

We would support this planning bed for 42 number houses.
