

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



LDP 2021 NN - . I would like to object to the proposed Local Development Plan for Potterton which presents OP1 and OP2 for potential development.

Reason for change:

The proposal would equate to a mass development which would over triple the size of the village. The onslaught of extensive building would be disastrous for the village to experience and would be an unnecessary destruction of green belt land which surrounds and protects the village.

Such a mass development in such a small village would be intolerable for the local community to experience. The proposed plans would irrevocably change the shape, character and future of the village.

There are already 7.2 years of land supply available and enough local development already planned and in development to maintain an adequate supply and should not include the destruction and loss of green belt land with overdevelopment and urban sprawl that will negatively impact upon a small rural village surrounded by green belt and farm land.

The village has a few services and shares additional services available in nearby villages . There is no evidence to substantiate the statement that the long term viability of existing services may be threatened unless growth is permitted.
