## PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

LDP 2021 NN- The transportation note within the main issues report was completed by RPS Ltd on behalf of the proposed developer for OP1 and OP2. Within the transportation note they consider there to be no impact on the village by the construction traffic and thereafter by a higher level of traffic from new properties. This is an inaccurate assumption. I request that this report is reviewed as a matter of urgency.

#### **Reason for change:**

The potential plans are in the area of the village bounded by c class roads. These roads are the second access point to the village. The main access being from the B999 at the other side of the village.

The c grade roads link from the village to the Black dog roundabout and AWPR. It is not structurally capable to take long term increased heavy use. During the completion of the AWPR HGV trucks were banned from this road and from access through the village. The road bounding the proposed land for development has narrow sections and limited passing places with homes located on either side of the road. The road leads onto Belhelvie or turns left at a hairpin bend and runs between homes without passing places which causes continued road safety issues in accessing the village by car or bus.

These narrow areas cannot be overcome to accommodate a bus and vehicle passing at the same time as houses are located in close proximity.

The roads are not suitable for the traffic that would be caused by extensive development. Statistically 233 homes could produce in excess of 360 cars. The noise and increased pollution from such a large development would have a detrimental impact within the community. The c class roads were not in the proposed LDP to be upgraded therefore would continue to be of single track generally and with an increased risk to all road users due to the additional impact of the extra cars using them.

In the plans Barratt propose to deliver road improvements to benefit the whole village and provide a new connection from the C class access road leading to the Blackdog roundabout. The proposed road would pass though the proposed development and connect with Manse Road. This would potentially provide a type of Rat run through a new housing estate but would not remove the constraints on the c class roads which will remain. The suggestion that traffic calming measures on the planned road would resolve any issues disguises the impact of heavy traffic passing through the residential area thus causing additional traffic safety issues .
