PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

LDP 2021 NN - Ongoing concerns from the local community council have continued to be noted in their meetings, and yet the proposed LDP does not raise education provision as an overwhelming constraint.

Reason for change:

At present children from the village are transported to Balmedie Primary School by bus. The school is over capacity and run down over years of from lack of investment. The community hall in Potterton has become the overspill for the nursery provision otherwise provided at Balmedie Primary. This is owing to an increase in young families moving into the Potterton community. Children of Academy age are transported into the Bridge of Don, an Aberdeen school. Should parents wish for their child to attend Ellon Academy, an Aberdeenshire school, then they have to pay or provide transport.

It is not appropriate to accept the promise of developers contribution as part of a potential housing development and then look to educational provision afterwards. Particularly in an area where educational provision is already stretched because of an intense programme of housing development already in place in this region. Educational need must be considered before any new development in the area is agreed.

A further overwhelming constraint on planning must be local health care provision.

I have been informed that heathcare provision is not the responsibility of the developer. Whilst I am aware of this, the developer should take serious cognisance of the local Healthcare provision along with distance and access to it.

Healthcare provision for Potterton is at present provided by Scotstown Health Centre in the Bridge of Don with a satellite surgery at Udny. At a recent local community meeting a senior Dr from the practice attended and highlighted his concerns and fears for local health care provision being inadequate and further over stretched. This statement took into account the growth in Balmedie, Blackdog and Bridge of Don and the impact and pressure on services.

These fears were highlighted before extensive growth proposals were considered for Potterton or the Pandemic was upon us. Community Health must be considered above developer needs. Now above all given the impact of the Pandemic, capability within the area to meet healthcare provision must be considered as of high importance a lack of consideration would be reckless in the extreme.
