PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

LDP 2021 NN - I request that the LDP plans are modified to take into account the present impact of the deterioration of the oil industry and also the potential results of Brexit upon the Aberdeen and Aberdeenshire economic climate

Reason for change:

We face an unpredictable economic recovery following the Covid 19 Pandemic. Reporting within the proposed LDP will not have been able to include the damage created in terms of the socio economic impact on Aberdeen and Aberdeenshire.

The LDP plans do not account for the present economic climate which continues to deteriorate. Until 2015 Aberdeenshire experienced a long period of growth with high demand for housing. Since the fall of the oil price tens of thousands of jobs have been lost locally. Oil companies remaining in the region are continuing to down size. The impact that deterioration of the main employment area is having in Aberdeen and Aberdeenshire and the resulting impact upon the housing market should not be ignored in planning.
