As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Support to retain OP1 allocation for 15 houses as per planning approval, and support to include bid FR098 (allocation OP2)

Reason for change:

The plan intimates that the development shall be for 5no. units to OP1 and 35no. to OP2. We (as A.J. Rennie Ltd) are currently collating information to finalise details for an initial 15no. units which we are keen to develop at our earliest opportunity. This was previously agreed as OP1 in the earlier LDP for Aberdeenshire.

We would be keen to continue develop the further 35no. units which we believe would be highly beneficial to the area, even creating employment opportunities through a possible future farm shop & café. Such facilities would greatly compliment this size of development, in turn being sustained by the development itself.

Therefore we believe the zoning in OP2 for an additional 35no. units, additional to the current 15no. units, should be accepted.
