

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

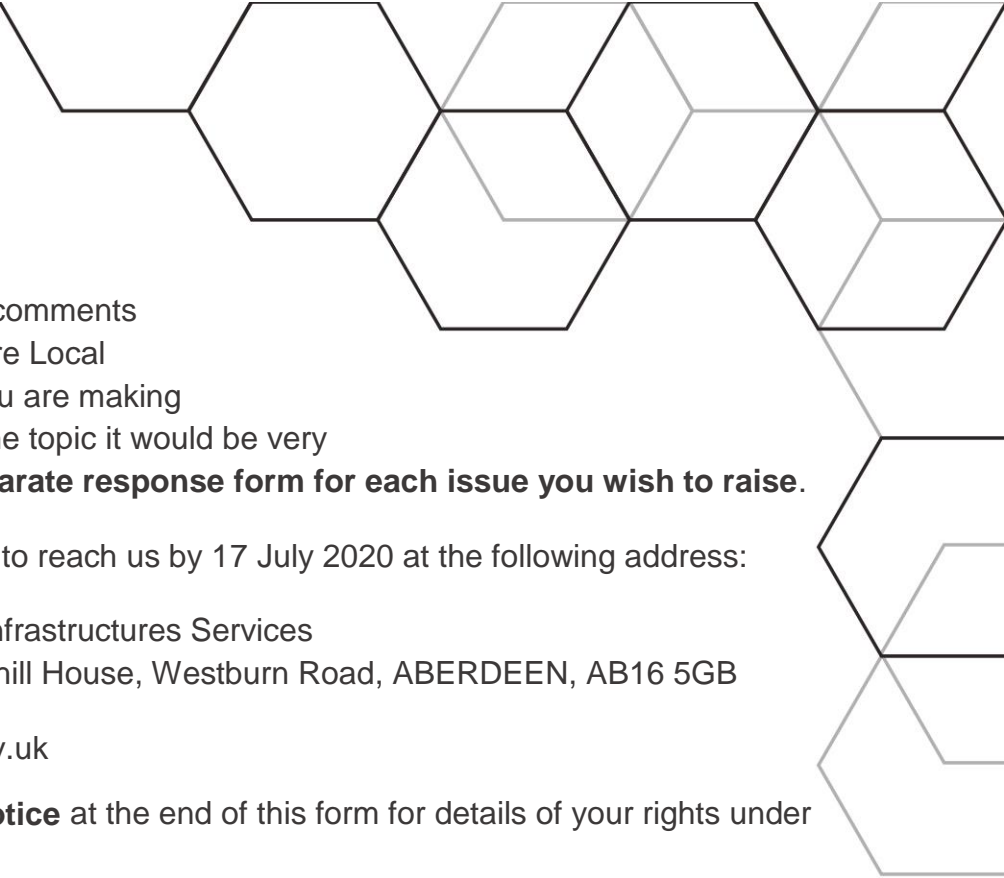

**Marywell Settlement Statement:**

**Site OP1 – Land East of Old Stonehaven Road should be removed from the Local Development Plan**

**Reason for change:**

We object to the zoning of OP1 at Marywell (Land East of Old Stonehaven Road). The vision for Marywell in the adopted Local Development Plan is to provide employment land. It is therefore somewhat surprising that a housing site is now proposed immediately adjacent to this employment land. Concerns regarding this juxtaposition of land uses were expressed by officers in their Actions and Issues Paper – Kincardine and Mearns where they stated, "we agree with the risk of this development being in close proximity to the business site and the impact of this". They suggest a buffer could counteract this but it is our opinion that to ensure there are no constraints to the provision of employment land this site should also be designated for business use to avoid conflict.

Marywell has a distinct lack of amenities and services. This again is recognised by officers who advise "facilities are available in neighbouring towns" (Actions and Issues Paper – Kincardine and Mearns). Development at Marywell would be contrary to the aims of the Local Development Plan which at paragraph 3.13 promotes "sustainable development that reduces the need to travel, reduces the reliance on private cars and promotes safe and convenient travel opportunities." The fact that the services for residential development are in a separate town merely encourages travel and is less sustainable than allocation homes to towns with services and facilities. We also note that the community council do not wish to see any further development in Marywell.

This allocation should therefore be removed with the homes reallocated to Stonehaven or Portlethen where there are existing facilities and services.
