

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

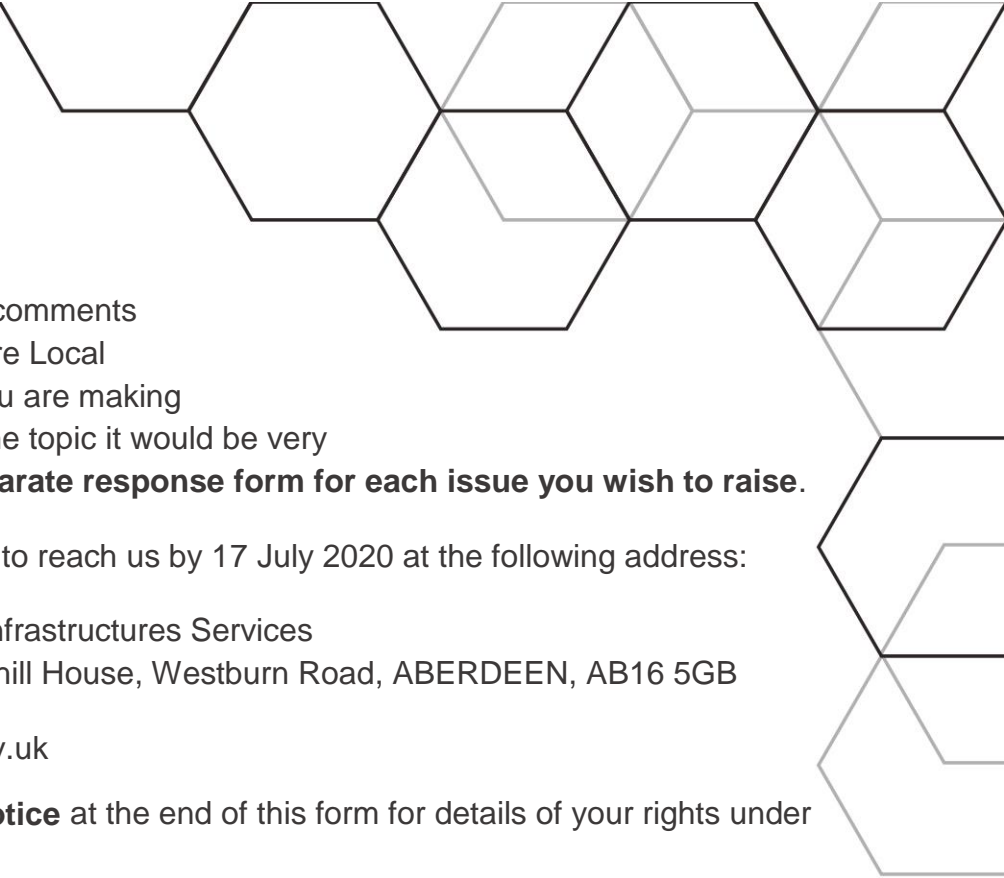

Portlethen Settlement Statement – no modification required.

Reason for change:

We welcome that the site to the North of Thistle Drive, Portlethen (site reference KN027) has not been taken forward as an opportunity site in the Proposed Local Development Plan. The site was proposed by officers as a preferred site for development through the Main Issues Report (MIR) and the draft Proposed Plan (dPP) however it is our opinion that more appropriate sites are available for development in Portlethen.

The site, bounded by the A92(T) Trunk road to the west and the East Coast Rail line to the east, is constrained due to amenity as a result of noise and air quality impacts from these two strategic routes. Additionally, officers in their assessment of the site in the MIR express a number of concerns relating to the visual prominence, visual impact and issues of coalescence to the north of Portlethen. The site is also at risk of flooding as confirmed by SEPA floodmaps. Access to the site via Thistle Drive is compromised given the width of the road and there currently only being a footpath on one side of the street. Whilst it may be possible to provide a second footpath, there are a number of pinch points that would involve the removal of traditional drystone dykes and potentially the need to negotiate with third party landowners. The road is narrow and does not provide scope for a bus service. The site is therefore remote from public transport with the nearest part of the site being some 530m away from a bus stop.

Upgrades would be required to Cookston Road to accommodate the scale of the proposed development and it is unknown whether the land for this is under the control of the developer.

In conclusion, there are a number of constraints to development at KN027 with more appropriate and sustainable locations for development in Portlethen, such as the sites at Clashfarquhar (KN082) and Schoolhill (KN057). It is welcomed that the Thistle Drive site has not been progressed as an opportunity site.
