

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

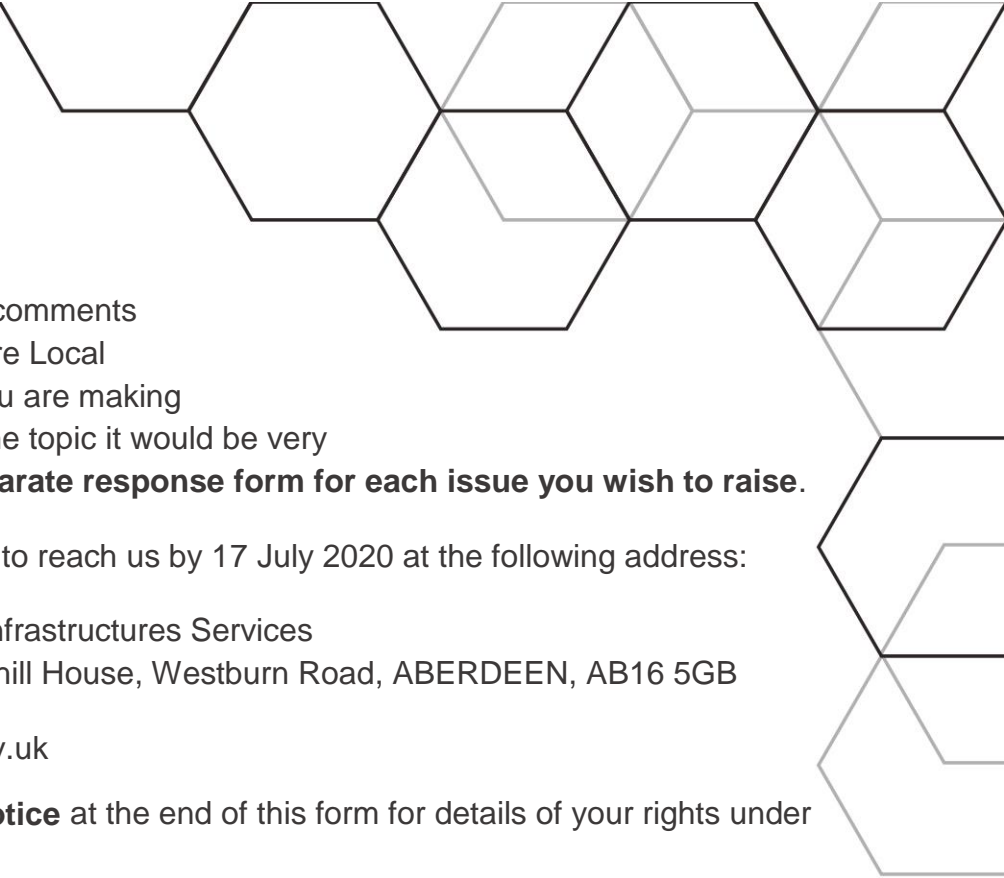

Portlethen Settlement Statement (Kincardine & Mearns)

Site R1: Reserved Land – Safeguarded for a Park and Ride facility –

The site should be included as part of the BUS2 allocation and safeguarded for Business Use.

Reason for change:

We object to the continued zoning of site R1 as reserved land for a park and ride facility. The site has the benefit of a Class 4 "Business Use" consent and this should be recognised in the zoning of the site in the Local Development Plan. Despite Aberdeenshire Council's suggestions to the contrary at the Main Issues Report (MIR) and in their Actions and Issues Paper – Kincardine and Mearns, there is no doubt that this site has the benefit of this Class 4 consent, a consent it shares with the site BUS2. Planning consent ref App 2014/1747 extended planning consent reference APP/2000/0006 and consent is valid until December 2020. A planning application will be lodged in the near future to extend the consent given the delays in selling the site as a result of the Covid 19 pandemic.

It is not reasonable that Aberdeenshire Council are seeking to sterilise the land for Park and Ride when they have not brought land forward or attempted to purchase the site despite having lodged a planning application for a park and rise in 2011 and had consent since 2014. The continued safeguarding of the site does not serve a planning purpose and is purely sterilising a site that is marketable business land. The site is located within the settlement boundary and has excellent connections to the Trunk Road network, and public transport and should accordingly be zoned for Business Use.
