

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

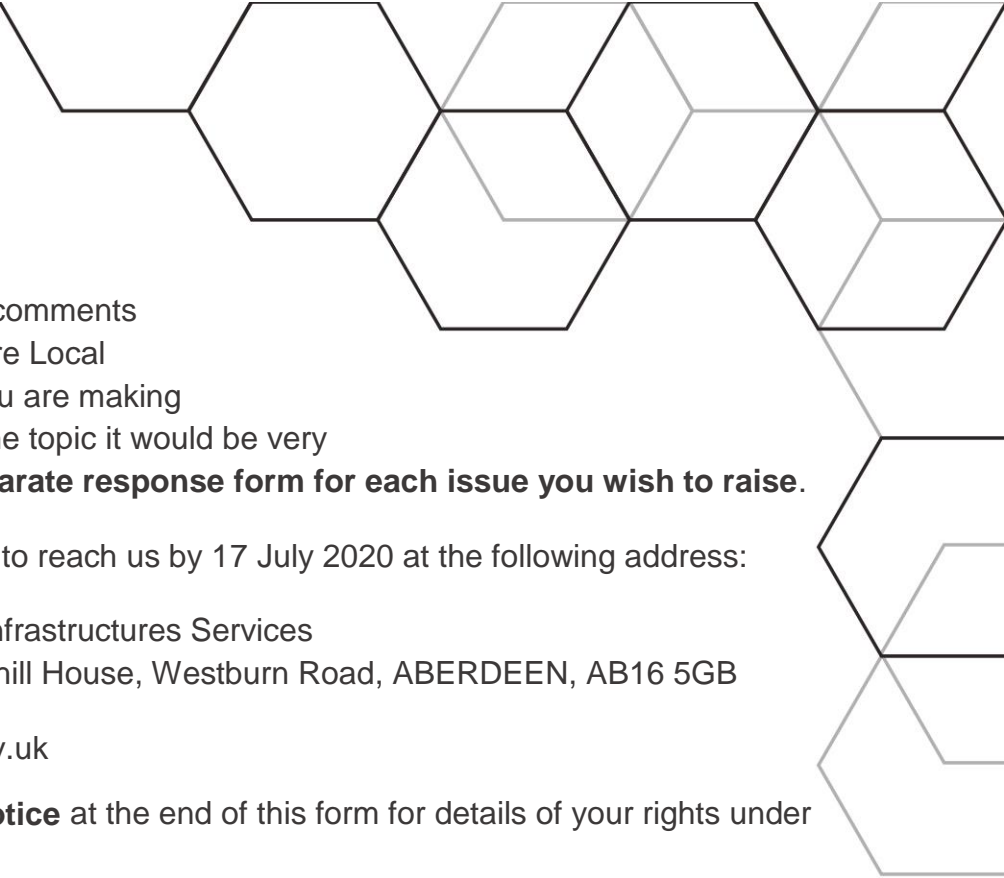

Westhill Settlement Statement:

OP2: Burnland

The site should be deleted as an opportunity site and should revert to "white land" within the settlement boundary

Reason for change:

We object to the site at Burnland, Westhill being zoned as an opportunity site for residential and retail/commercial development. It is recognised that an extant consent exists for the site by virtue of it being implemented for previous phases however, the site should not be zoned for development and should remain as "white land" as it was in the Aberdeenshire Local Development Plan 2017. The site is constrained and has been for many years as the landowner is unwilling to sell the land. Indeed this has been demonstrated recently in that despite there being an extant retail consent for this Burnland site, a planning application has been submitted for a site immediately to the north for retail as Burnland was not available for development.

It is disingenuous to now formerly allocate the site as an opportunity site for housing as it suggests a new site is being brought forward for development in Westhill. The Proposed Plan suggests that "efforts should be made to deliver this remaining phase" however given that the Delivery Programme makes no reference to using Compulsory Purchase Powers we do not believe that the Council can force the sale of the land. We also note that the Delivery Programme makes reference to Bett Homes who no longer exist. It is also notable that no bid has been put forward for the site during the plan making process.

SPP at paragraph 119 advises that Local Development Plans should allocate a range of sites which are effective or expected to be effective in the plan period. In allocating sites, planning authorities should be confident that the land can be brought forward in the plan period. This site was granted planning permission in 2008 and the last homes were completed on the development in 2013. There can be no confidence that the site will come forward within the lifetime of the plan. The site should therefore revert to white land and an alternative site should be allocated for housing to ensure a range of sites is available in the town.
