## PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Westhill Settlement Statement: Site OP3:

The requirement for a Noise Impact Assessment and appropriate mitigation to residential properties should be highlighted in the plan to protect established neighbouring businesses

#### Reason for change:

The Stewart Milne Group do not object in principle to the zoning of Opportunity site OP3 in Westhill for 63 affordable homes. We are however disappointed that the Proposed Local Development Plan does not reference the existing neighbouring industrial uses. These uses are generally noise emitting. For example, the Stewart Milne Timber Systems factory which has been located there since 1978 and the Westhill Garage are by their nature noise generating businesses. The Timber Systems factory which employs 131 people, has 24 hour production to meet customer need. This factory manufactures innovative timber framed buildings to deliver energy efficient buildings which can be erected quickly and safely on sites due to the off site construction techniques. This includes kits for housing and affordable housing that is delivered throughout the UK.

It is essential that the economic benefit arising from the neighbouring industrial uses is not compromised by future development. PAN 1/2011 "Planning and Noise" requires development plans to guide development to the right locations and where necessary specifying requirements for design and layouts can help prevent and minimise the consequences of noise pollution (Paragraph 11). The Aberdeenshire Local Development Plan should therefore reference that the design of any development on site OP3 in Westhill should include noise attenuation measures to protect these long established employment uses.
