

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

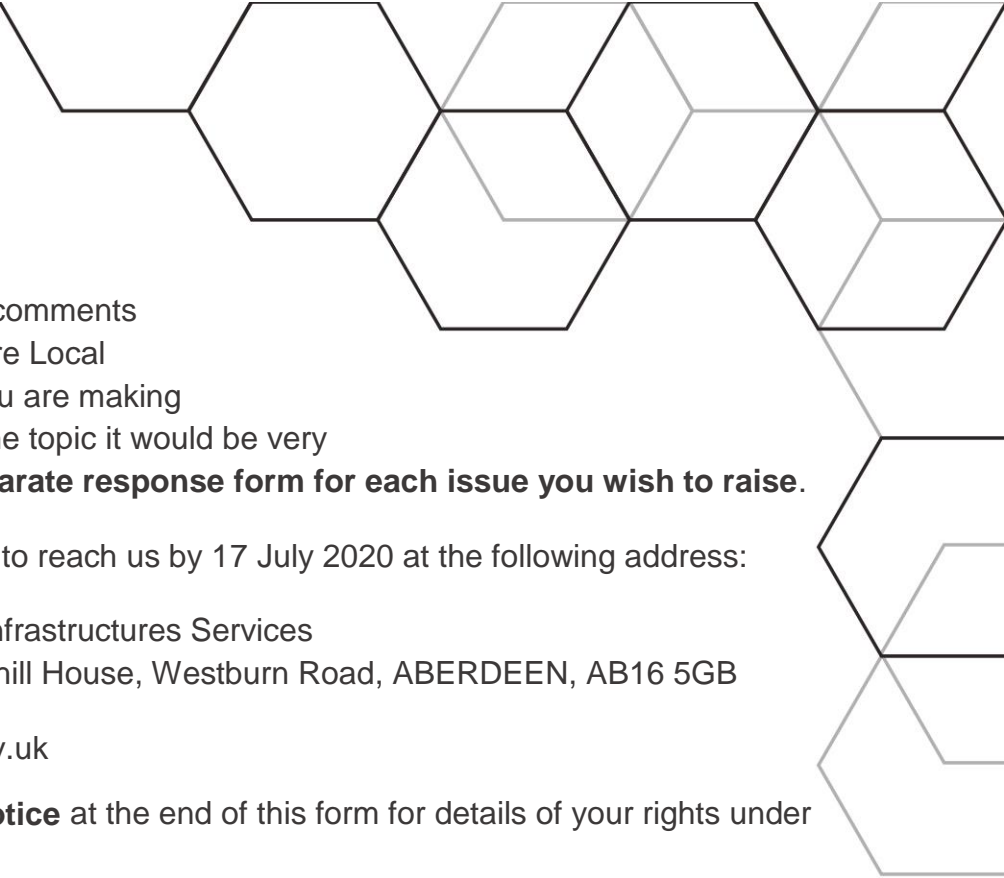

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Policy H2 – Affordable Housing

At paragraph H2.2 “must include 25% of the serviced plots for affordable housing” should be deleted and replaced with “should include no more than 25% of the total houses for affordable housing”

Footnote 3 on page 42 should be deleted

Reason for change:

We note and welcome that the H2 “Affordable Housing” sets a requirement of 25% for affordable housing. The terminology used however is somewhat clumsy and does not reflect the policy aspirations of Scottish Planning Policy (SPP). Paragraph 29 of SPP, advises that “the level of affordable housing required as a contribution within a market site should generally be no more than 25% of the total number of homes”. The policy should therefore be amended to avoid confusion and provide clarity as set out above.

We question the need for footnote 3 on page 42 of the Proposed Plan. This does not add to the policy and should be deleted. It is not up to the housebuilding industry by means of a “concerted effort” or otherwise to deliver deficits beyond the policy requirements.
