

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

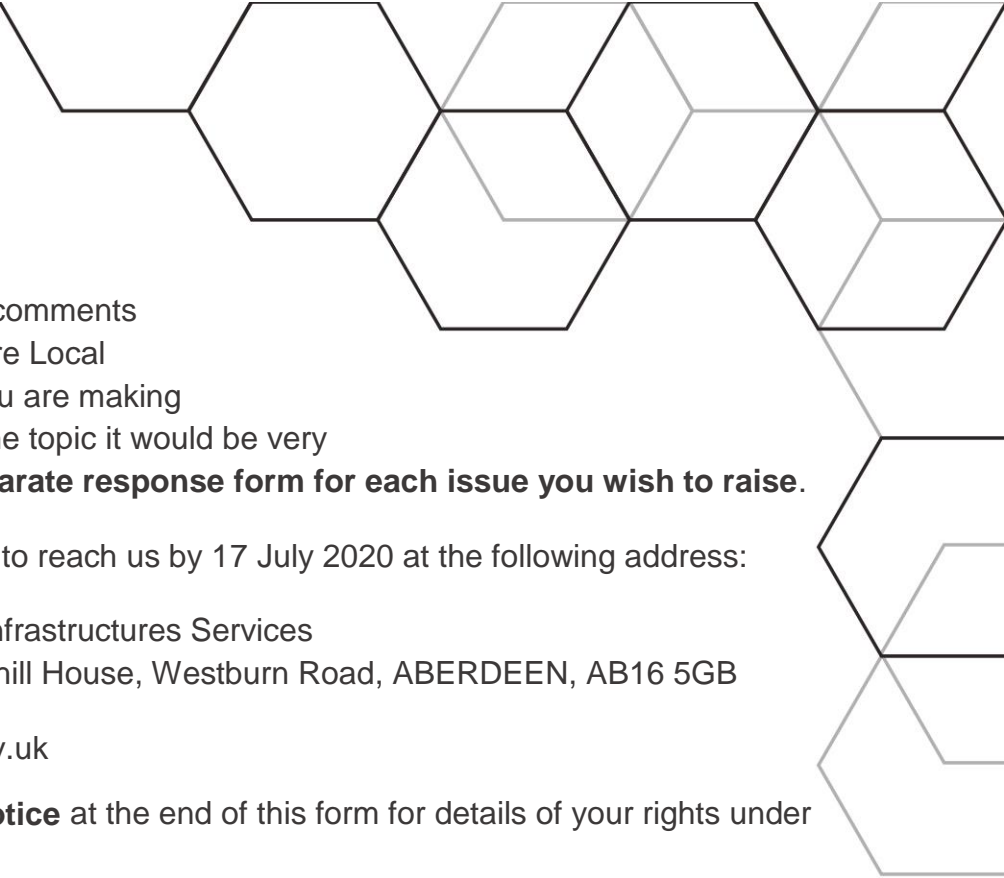

## **Policy P2 – Open Space and New Access in Development**

**The requirement for open space should be reduced from 40%**

### **Reason for change:**

The amount of open space required by Aberdeenshire Council is excessive and no justification for it has been put forward for it. Aberdeenshire Council have sought to increase the density of development on a number of sites and this requirement for open space is therefore contradictory. The Council do not adopt open space and therefore it requires homeowners to pay a factoring fee. The fee is dictated by the amount of open space and often results in an unnecessary burden on household finances especially for affordable homes.

This onerous open space requirement also has to be considered in the context of appropriate density for the site. This is not a one-size-fits-all solution and the layout and design approach for each site should be considered on its merits. Open space should be meaningful and attractive, providing recreational opportunities for existing and future residents. In order to ensure that this is achieved, it is submitted that this could be achieved by smaller but more meaningful spaces rather than simply applying an unsubstantiated percentage of the site.
