

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

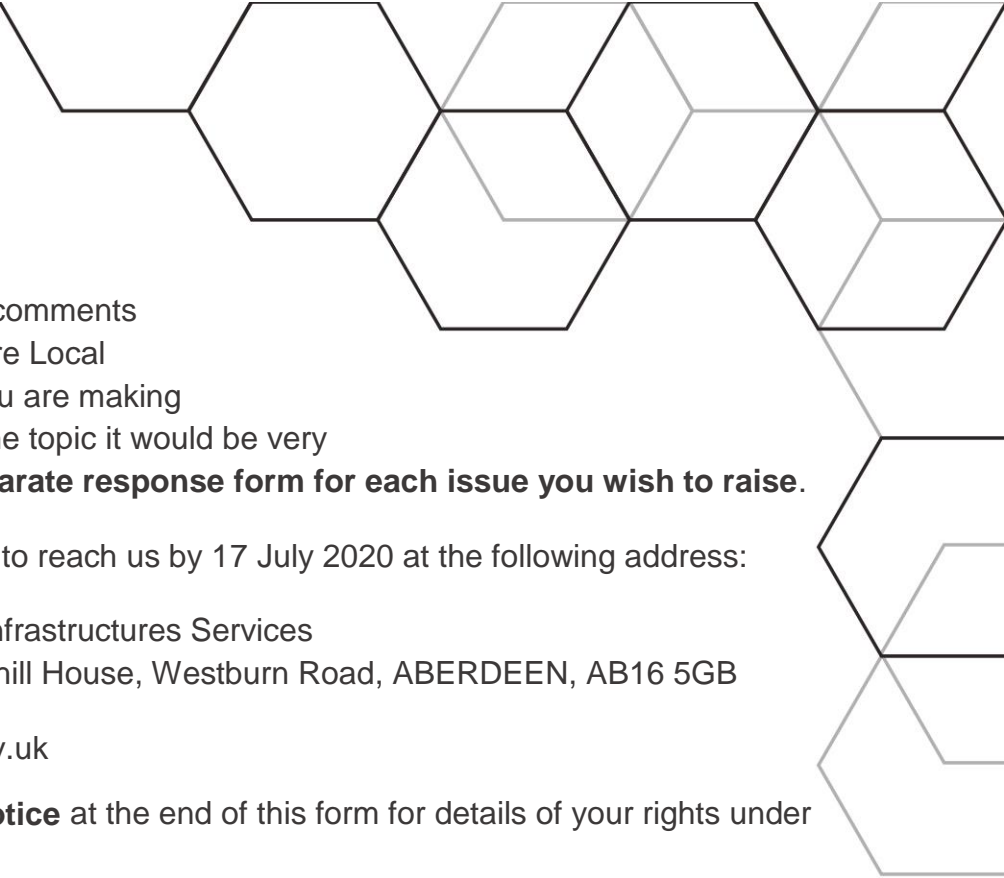

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Policy C1 – Using Resources in Buildings

Remove references to silver and gold standards for emissions and water.

Make reference to any requirements shall not exceed the Building Regulations prevailing at the time of consent.

Reason for change:

We welcome that Aberdeenshire Council have not pursued the Platinum standard option to secure carbon-dioxide and energy cost reductions as suggested in the Main Issues Report. In securing the silver measures now proposed it should be made clear that at all times planning policy will not seek to secure greater reductions than the Building Regulations prevailing at the time. Further, where the appropriate reductions can be made through the fabric of a building there should be no requirement for low and zero carbon generating technologies to be added to buildings. References to silver and gold standard for emissions and water should be removed as these are better dealt with through the statutory building regulations process.

We are firmly of the view that emission standards for new buildings should be dealt with by the Building Regulations processes which are regularly updated in terms of new standards.
