

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Policy RD1 – Providing Suitable Services

RD1.1 The policy should be explicit to limit Hydrogen Fuel Stations to commercial developments and only where practical and viable

RD1.4 Any contributions sought in respect of public transport should “fairly and reasonably relate to the proposed development”

Reason for change:

Hydrogen fuel stations are unlikely to be appropriate within residential developments for amenity reasons and this should be made clear within the Local Development Plan. Their provision should be restricted to commercial developments where they can be delivered safely and viably.

Whilst we recognise the need for development to be sustainable any contributions towards public transport (RD1.4) must be reasonable in terms of the test set out in Circular 3/2012. Obligations must fairly and reasonably relate to the proposed development and it must be recognised that in zoning a site for development the Council will have assessed that it is well related to public transport. Where contributions are required, they should be set out in the zoning for the site.
