

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

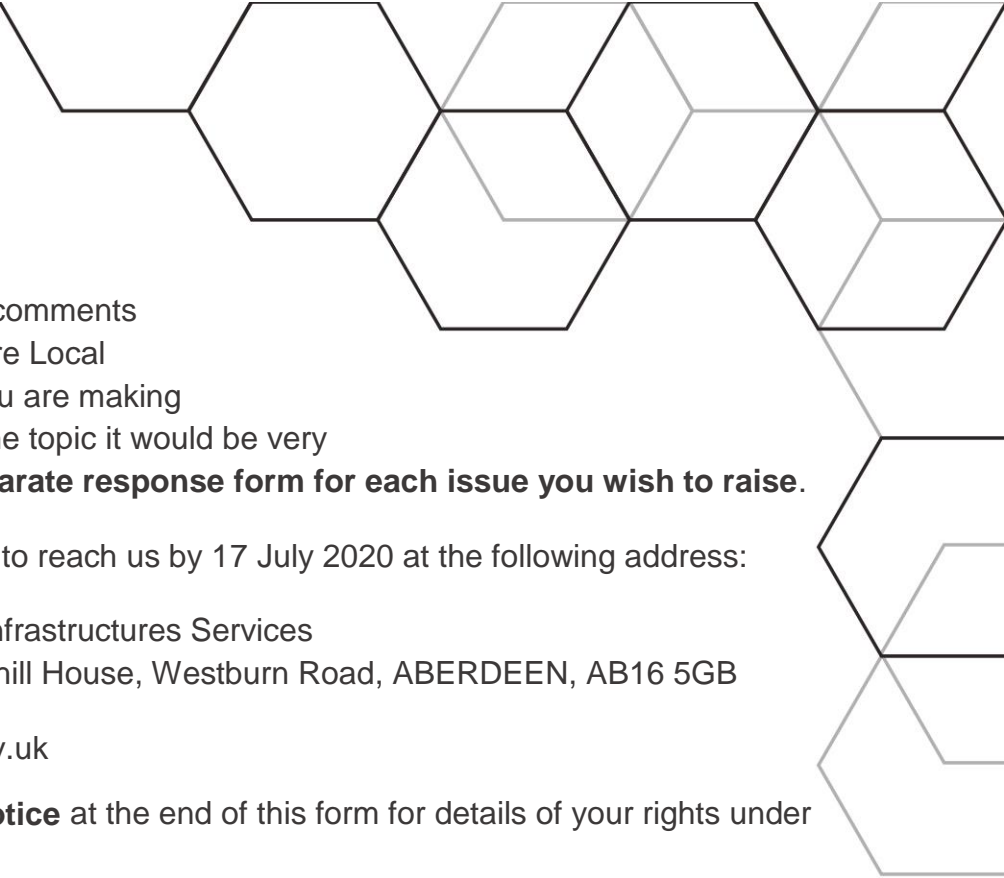

## **Policy RD2 Developer Obligations**

**The policy should be amended to reflect the full policy tests of Circular 3/2012. The policy should also be explicit that contributions will not compromise the viability of development.**

**A full justification is required for the contributions set out in Appendix 7. Detailed justification is required on a site by site basis.**

**The requirement for contributions to healthcare facilities should be deleted.**

## **Reason for change:**

The policy fails to fully reflect the wording of Circular 3/2012 and provides no justifications for the contributions being sought through the settlement statements in Appendix 7. Any contributions must meet all 5 tests as set out in the Circular. The contributions for each settlement statement have not been justified on a settlement basis nor a site basis and appears purely as a wish list. This must be provided by Aberdeenshire Council in order that it can be scrutinised as part of the Plan and to ensure the housing allocations are indeed viable.

We object to the Council seeking contributions to Healthcare facilities. Many GP practices in the NHS Grampian area are run as private businesses and it is wrong to seek funding for a private business. The NHS is already funded through general taxation and an additional levy should not be required from housebuilders. In addition, the Council has no control as to where money is spent. For example, Aberdeenshire Council as education authority have the ability to extend a school or amend a catchment boundary. They cannot make these decisions for medical facilities.
