

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



# YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. **Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

**Taylor Wimpey/The Mitchell Partnership formally object to the allocation of land to the west of Bennachie Care Home, Inverurie (Site OP15) for residential uses for circa 130 new residential units.**

## Reason for change:

**In comparison to Taylor Wimpey / The Mitchell Partnership's proposed residential land allocation at Souterford and Souterford (which is the matter of separate objections against their non allocation), the identification of OP15 is neither logical or appropriate and runs counter to policies included within the proposed ALDP 2021; In particular in respect of sustainable development.**

Notwithstanding the Council's reluctance to identify any new land at Inverurie as a consequence of, in their view, sufficient land already allocated for residential purposes and uncertainty in respect of the potential consequences of the future dualling of the A96, the Council have identified new housing land within the proposed ALDP 2021. Whilst this is welcomed and supported in principle, the choice of land to the West of Bennachie Care Home (site OP15) is challenged.

Site OP15 lies to the far north west of Inverurie and lies immediately adjacent to and below the A96. It is at the edge of an existing residential area. It is submitted that this is an odd choice for a residential land allocation given that:

(a) the site is unsustainably located given its distance from the town centre, shops, including the town's supermarkets, the train station and bus interchange, and the local primary school. Realistically, the vast majority of journeys to all of these will need to be by car. Walking is not an option. This cannot be considered as a sustainable location.

(b) further extends the settlement along the edge of the A96;

(c) is on a north facing slope meaning poor passive solar gain. This cannot be considered as a sustainable location particularly if alternative locations that are south facing present themselves.

(d) is understood to be partially within a designated historic battlefield location.

It is noted that whilst point (a) is submitted as a matter of fact, points (b) – (d) were actually noted by officers' in their response to the previous ALDP's MIR.

Whilst the allocation of new housing land is welcomed and supported by Taylor Wimpey / The Mitchell Partnership, rather than at site OP15 it is submitted that this new land should be at Souterford given that, by comparison with the points raised above, it is:

- (a) Sustainably located where walking is a very realistic option given the site's close proximity to the town centre and rail / bus interchange;
- (b) Is within a gap site between the town centre and the current Uryside residential development;
- (c) is on a south facing slope allowing maximum solar gain; and
- (d) is not on a designated historic battlefield.

It is therefore submitted that site OP15 be deleted from the proposed ALDP 2021 with the subsequent identification of land at Souterford in its place.
