As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Point 1)

Currently there is a BUS proposed directly behind our site. I wish for this to be removed.

Point 2) Shaping Places - References are made to the historic environment, and to community facilities, but no specific reference to the positive contribution of cultural and arts facilities in the area, and their importance in the creation of vibrant, diverse communities.

Point 3) Rural Areas – more emphasis should be given to rural areas out with the 'Special Rural Areas'. The tone of the text, describing the majority of rural areas as 'Elsewhere' arguably implies that these areas are of lesser worth. The importance of transport infrastructure to these areas, and of community amenities such as local shops and pubs as hubs of community life, should be given more weight in the Development Plan.

Reason for change:

Point 1)

If a new business development were to be put in the proposed position it would negatively impact our business at SSW. We are one of the remaining businesses in the village and we run a highly successful space for artists to visit from all over the world and local communities to meet and make.

We have recently been granted planning permission for our site which if a building where created in this BUS site then all the natural light of our new proposed workshops and site lines will be highly diminished.
