

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

The Objectors wish to see a change to the definition of brownfield land in the Glossary to allow land formerly used for Class 6 storage and distribution uses to be considered as brownfield land.

Reason for change:

The Glossary defines Brownfield Development/Land/Sites (under Policy R2) as: "*Land/buildings found outwith settlements that have previously been developed or used for some purpose that has now ceased and on which a new use has not been established. Land/buildings will be vacant, redundant or derelict. Excluded are private and public gardens, domestic garages, sports and recreational grounds, woodlands and amenity open space, buildings or land being used for storage purposes e.g. silage clamps or other specialised agricultural structure, temporary buildings e.g. garden sheds and huts, reinstated sites e.g. former quarries or sites with unimplemented conditions for reinstatement, wells and pump-houses, hardstandings, agricultural buildings constructed using modern materials, including where such buildings are subject to storm damage and sites disused or redundant for so long that they have become naturalised.*"

The definition is very similar to the definition in the 2017 LDP, however the extant definition includes the potential for the excluded sites listed above to be considered as brownfield opportunities in rural areas.

The definition differs from the definition of brownfield land in Scottish Planning Policy and the current and emerging Strategic Development Plan. In particular, the draft LDP excludes Class 6 uses from the definition of brownfield land. This conflict means that one part of the Development Plan is in conflict with the other, as well as in conflict with Scottish Government guidance.

There is no justification given for the exclusion of buildings or land which were previously used for storage purposes from the definition of brownfield land. Why should a specific use be excluded?

Brownfield land is usually considered to be land which has previously been developed or used for a purpose and that purpose is no longer required, such that the land or buildings are now vacant or derelict. Planning policy encourages the redevelopment of such sites for other uses to preserve greenfield land from development. Redeveloping brownfield land is a central plank on

sustainable development as it is reusing land which has previously been accepted as suitable for development and taking advantage of the services and infrastructure which is already in place to serve the previous use.

The definition should be changed to allow land and buildings in the countryside which has previously been used for non-agricultural related storage and/or distribution uses to be considered to be brownfield land and thus suitable for redevelopment, subject to compliance with other relevant planning policies.
