# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

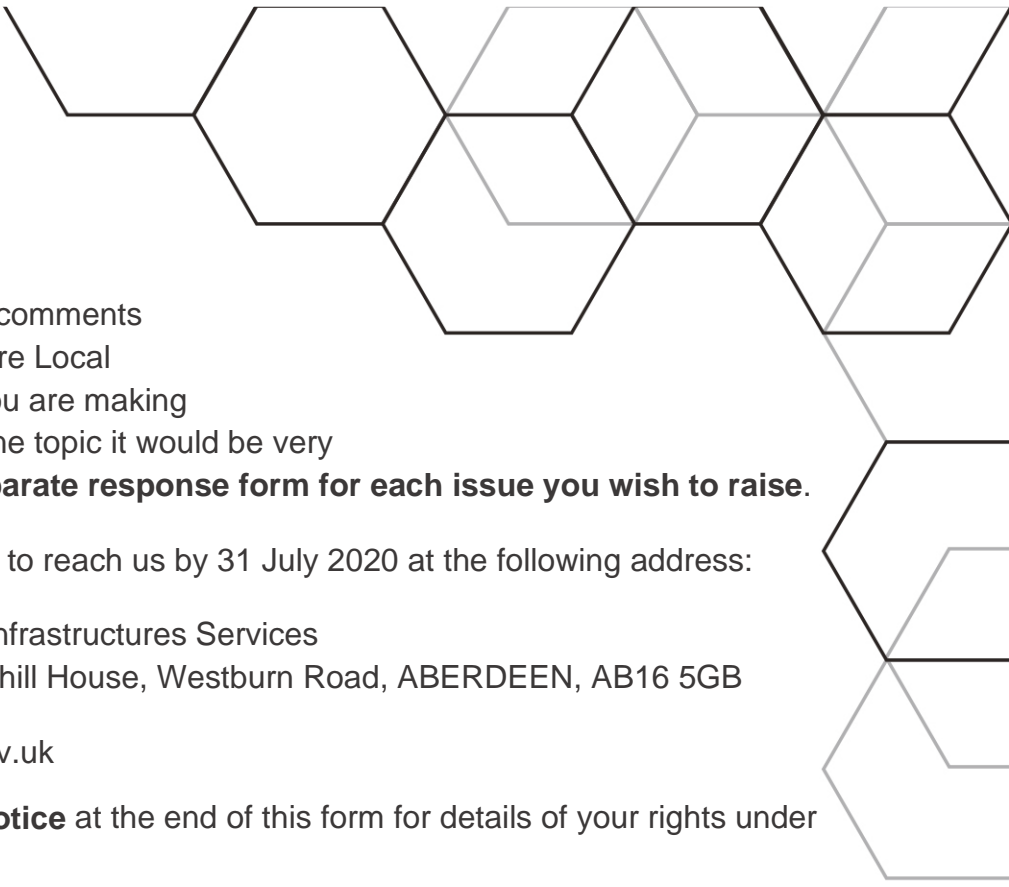

# YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. We will publish your name as the author of the comment, but will not make your address public.

**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Page 330 – OP6: Land North of Balring Road.

1. Amend the text: "The row of trees to the north and south should be retained." Replace with the text "Any loss of trees should be minimised where possible, and any loss of trees on the Balring Road should consider suitable compensatory planting."
2. Amend the text: "Adequate public transport infrastructure on the A952 must be provided to achieve active travel, including bus stops." Replace with the text "Public transport infrastructure should be provided on the Balring Road to serve the OP2 and OP6 developments."

**Reason for change:**

1. OP6 will be accessed from Balring Road which requires to be upgraded to an adoptable standard. It will therefore be impossible to retain the trees along Balring Road. The text should be amended to state that tree loss associated with the new access and upgrading of Balring Road should be minimised, and compensatory planting should be considered. This amendment is important to ensure the trees on Balring Road do not become an impediment to OP6 the development.
2. The reference to public transport infrastructure on the A952 does not relate to the OP6 development. The provision of public transport infrastructure in this location would be detrimental to the woodland on the A952. The most appropriate solution is to provide public transport infrastructure on the Balring Road which will serve the OP6 and OP2 developments in Mintlaw.
