# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020

## RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.


Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Page 219, OP4: Land at Tyronhill Farm.

- 1. The allocation should be increased to around 40-50 housing units to reflect the physical capacity of this site.
- 2. The reference to the retention of the existing granite steading buildings should be removed.

#### Reason for change:

- 1. The site is able to accommodate more than 30 units. The proposed increase will represent a more efficient use of the land. It will also be consistent with the other LDP allocations which tend to be between 20-30 dwellings per hectare. This site promoter has carried out a review of the OP4 site and is confident that it can accommodate more than 30 units.
- 2. The existing granite buildings are mostly in a state of disrepair, and their retention is not preferred by the landowner/developer from a commercial and aesthetic perspective. The stipulation that these buildings should be retained is an unduly prescriptive level of detail that will be decided through appropriate design analysis and structural survey as part of a future planning application. As such, reference to the retention of these buildings (or the need for a design statement with evidence to justify their loss) should be deleted.
