## PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

#### Reason for change:

This response is submitted on behalf of Deeside Climate Action Network, a local action group supported by approx 50 local residents of Banchory and other communities on Deeside (Torphins, Aboyne, Tarland etc). Our website is http://deesidecan.org.uk/

The Climate Change (Scotland) Act 2009. The Bill was passed on 25 September 2019, receiving Royal Assent on 31 October 2019. The Act sets a target date of 2045 for reaching net-zero emissions, with 70% emissions reduction as the target for 2030 and 90% emissions reduction by 2040. In developing the 2021 LDP, cognisance should be taken of these targets.

These comments are related to the proposed developments in Banchory (p.781). There are currently 5 housing developments proposed in the town. OP1, OP2 OP3 OP4 and OP6. Together they comprise a possible 402 houses.

My reason for change is a reduction in the housing proposed for Banchory on the grounds of the increase in Carbon Footprint from commuting traffic. However we also think the council could do more to reduce commuting miles.

The majority of work commutes from Banchory are to Aberdeen. There is a lot of data to support this. The public transport infrastructure is only a bus service to central Aberdeen. There is very little interconnectivity and no options to large employment centres such as Dyce, ARI and Westhill. The area around Banchory includes a population with a high level of car ownership with many houses with more than one vehicle. There is also a significant area of larger (SUV)Vehicle ownership in the area. A simple calculation shows that there is a potential rise in CO<sub>2</sub> emissions from these potential houses of 256T from commuting alone.

(assuming 40% of households have a commuter, 25km one way trip 5 days a week 48 weeks of the year in a vehicle emitting 133g  $CO_2$  per km. resulting in 256T )

We feel this could be mitigated by creating a better bus transport system. I am not aware of any mitigation by the council.

Encouraging car sharing locally. Cycling, improve Deeside way, put in a place to park and ride(by bike or bus), with ebike charging. Buses able to take bikes (more than the possible 2 at present if there are no buggies or other luggage). Alternatively the workplaces could be brought nearer to home if there were decentralised offices that people could go to instead of travelling to large centres. (or home working of course, that has suddenly become more possible).

We wish to add that we found accessing the documents and the information very easy and logical and possibly better on line in this format than the local engagement might have been.
