

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Section 13 Climate Change, Page 86. Bennachie has been given special framework classification of Group 3 for the purposes of windfarm planning. The Bailies of Bennachie suggest that Bennachie, as defined by SLA boundaries in Appendix 13, p 1077, be re-classified to Group 2.

Reason for change:

The Bailies of Bennachie welcome the opportunity to comment on proposed Local Development Plan 2020 (LDP) for Aberdeenshire.

We note from LDP Section 13 Climate Change, Page 86, that for the purposes of special framework mapping, the area of Bennachie seems to have been mostly classified Group 3 (apart from two highly localised areas), with regard to wind farm development. The Bailies of Bennachie are greatly concerned that Group 3 affords the lowest level of protection and does not seem to be in line with Bennachie's status as a Special Landscape Area (SLA) and which is reflected and mapped in LDP Appendix 13 p 1077 as well as in Section 10 Natural History and Landscape, p 61.

Bennachie's SLA status recognises its iconic place in the Aberdeenshire landscape, which acknowledges the visual impact of its unique skyline and views, both towards and from various parts of the hill group, as well as its many sites of historic interest. Bennachie's paths and routes are widely used recreationally, positively impacting the physical and mental health of locals and visitors. These significant and diverse features combine to make Bennachie a major tourist attraction, to the benefit of the local economy. The Bailies of Bennachie would like to point out that placement of windfarm or turbine developments in areas on or around the hill group risk adversely affecting its visual impact and attractiveness to visitors, potentially reducing its recreational value. Windfarms may also compromise the archaeological record and endanger wildlife. We would therefore propose raising the whole area of Bennachie, as defined by its SLA boundaries to Group 2, which will allow a greater level of scrutiny over any windfarm and turbine planning applications and their subsequent placement in the area.

The Bailies of Bennachie fully supports efforts to combat climate change and the move towards clean energy. We hope that our comments will assist on locating wind turbines in ways that are most appropriate to the heritage, environment, visual amenity, and recreational value of the hill group, whilst also contributing to the local economy.
