

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



# YOUR COMMENTS

BU030 Land East of the Filling Station, Boddam

## Reason for change:

We have been met with a varied response to this site – while businesses would be keen to build and operate on this site, it is deemed constrained by:

(1) the LNCS status. However, the LNCS status is to protect geomorphology interests and upon reading the documents and guidance on this, this refers strongly to the Den of Boddam which is beyond Lendrum Terrace, around a mile south-west of the site, and also key features along ridge lines. It seems that this field has been included in the zoning by default as it adjoins higher-level fields which would require protection for the LNCS, however the application site is well outwith the scope that the LNCS guidance sets out to protect and would not pose any threat to/impact upon this.

(2) the land is within the Boddam Power Station consultation zone. We would be happy to consult with them, and we wonder whether the LDP team has consulted with them? We would imagine that the Power Station has no plans to compulsory-purchase or develop the available land closest to housing as no approach has been made to the owners and they have owned it for decades. Business development on this site would be controlled by the planning system by having uses compatible with closer proximity to housing, as the existing businesses in that area have established over the years. Again, it looks like this is included in the Power Station Consultation area by default, and not for any other specific reason.

(3) visual impact – the site is on a stretch of low-lying land and while it is currently an agricultural field, the developed area could be set back behind a strong belt of planting/bunding onto the road for a pleasant aesthetic, and passing traffic would only see that and the site entrance with development taking place on the lower-lying land would be screened off behind it. Access is achievable onto the road too.

In summary, there is interest and desire from businesses to develop on this land, which is available for development, and which can be controlled and planned in a structured manner secured by allocating this for business use zoning in the LDP.
