

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



BU031 Land North of Fair View, Boddam

Reason for change:

We write in support of our bid BU031 on behalf of the landowner. Reducing the developable sites in Boddam to just 9 units on OP1 would seriously restrict opportunities for Boddam, which is a great location for development within a short distance of Peterhead and on a main bus route, and Boddam has many businesses contained within it which also need support.

We realise that being across the main road from most (not all) of the houses and businesses in the village poses a challenge but this is not insurmountable - this is reflected in the settlement statement, stating that new development is "*required to contribute to footway extensions, upgrades and crossing facilities, cycle infrastructure and public transport provision*", all of which can be contained within the site. Upon initial investigation, a stacking lane for turning into the site would be a potential access solution, and this could be considered to accommodate bus-turning/pick-up facilities too. A means of pedestrian crossing is essential, whether via a pedestrian crossing incorporated safely within the design of the new site access, or a bridge/underpass at the P5 protected area as previously discussed when planning was granted for development of that land.

Although technically within the LNCS status area, the LNCS status strives to protect ridge areas for geomorphological interests and so this site being on lower-lying areas would not have any impact upon the LNCS status, as is shown that Lendrum Terrace being built many years did not have any impact on this.

Creation of safer walking routes throughout the site linking to wider networks such as the Lendrum Terrace road and other paths to the west would be promoted so as to limit/eliminate impact to the SSSI, SAC, and SPA areas to the east. The SSSI, SAC and SPA status areas mean that this is the ONLY way Boddam can develop in future, whether it is in this LDP or the next. We believe that this site would be popular and sought after for developers highlighted by the recent vying for development land in nearby Peterhead.
