

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

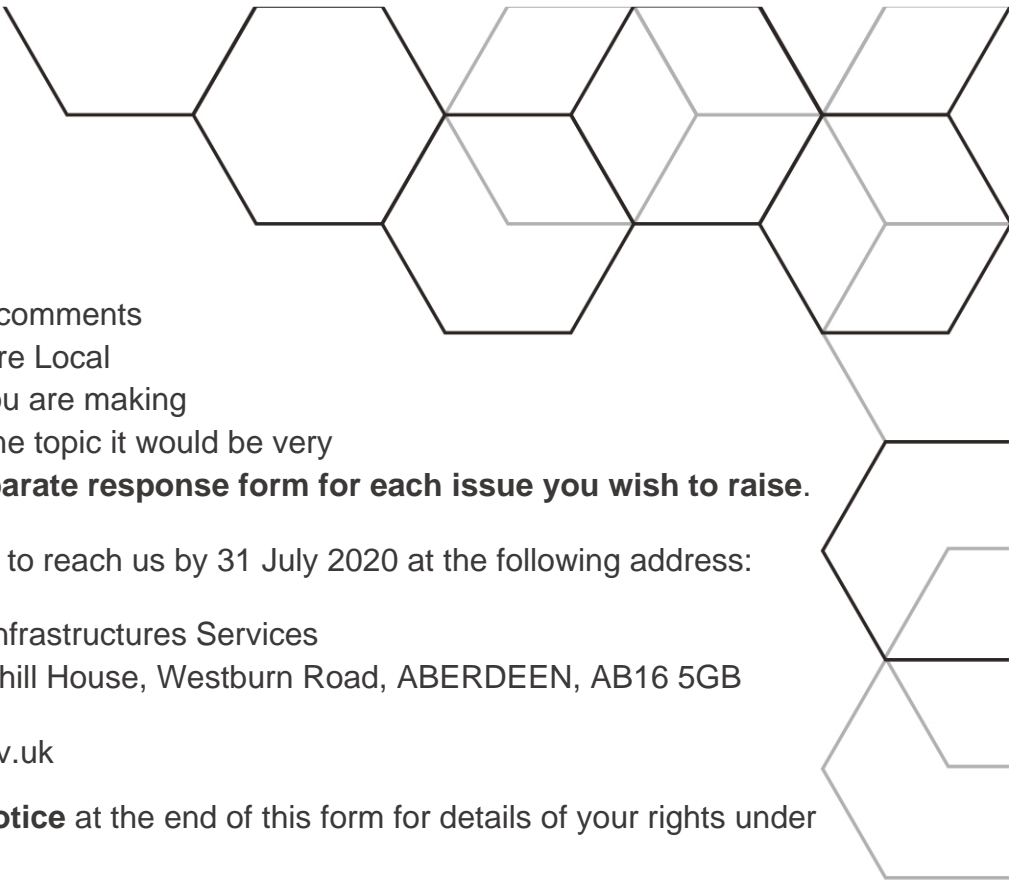

Reason for change:

I make my representation to the proposed LDP as a young person embarking on a professional career and aspiring to purchase my first home in Inverurie within the next few years.

There is limited choice in the Inverurie housing market. A small number of developers have monopoly, sites are slow in coming forward and the town's progress is being hindered by a reliance on, and endless delays in, receiving a decision on the route of the A96 dualling.

I was, therefore, encouraged to see some additional land being included in the proposed development plan. However, of all the sites put forward I am surprised by and object to what appears to be a random selection of OP15 and OP16 as the only "newly allocated" sites.

The location of these sites is outwith the settlement boundary on the northern extremity of town. They are remote from established community services (shops, health, leisure, education and public transport links) and distant from spaces for social interaction. I further consider that the location of OP15 and OP16 fails to adhere to key principles of the plan in that it does not provide sustainable development, it does not support the town centre and it does not help to lower the carbon footprint.

Instead, I urge that consideration is given to development that will better connect with and sustain facilities in Inverurie, particularly those which have been so negatively impacted by the global pandemic and economic downturn.
