

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

APPENDIX 7E SETTLEMENT STATEMENTS KINCARDINE AND MEARNES.

**OP1:** Land to the Northwest of Fettercairn: I wish to oppose the proposed allocation of 60 new homes. I would amend this proposal by not permitting the development of 60 new homes.

## Reason for change:

Fettercairn saw introduction of a large new housing development around 5 years ago. The Cairngrove development. There has been no change or uplift in local infrastructure to account for this influx. Aberdeenshire Council did not fully adopt this site with locals having to pay to support various aspects of the development. I do not believe there would be any increase in support or investment to the area that would amend this and also provide suitable provision for another 60 homes.

The nursery and primary school already has difficulty with capacity and there have been families turned away. It is then difficult to see how more families in the area requiring access to this would be serviced.

Water/waste was terribly troublesome for the first few years of the new village development. The area of the Distillery road including school have suffered from terrible old, overburdened water supply for many, many years. With no improvements being made whatsoever. Again, this does not support the introduction of 60 new homes.

The council stopped subsidising public transport to the village over 5 years ago, there is currently none whatsoever. So accessibility is already limited.

Despite the statement in your document "Fettercairn Distillery provides local employment" it only provides around 10 jobs (some of which are seasonal) which rarely become available as staff turnover is extremely low. So employment opportunities in the area are very low. Again this does not support an increase in population.

The addition of these homes would dramatically increase traffic flow through a very small village (particularly near the nursery and primary school which increases risks to the children) which has poor connectivity to the A90 North due to rail bridge closures off the B966 and in Fourdon.

If we could see proactive development and improvement to the current village infrastructure, services and support I would potentially support this development but do not believe it is acceptable to proceed and place a tremendous stress on the already strained village systems/services. Proceeding with "promises" of retrospectively making improvements, which was falsely promised with the previous development is unacceptable. Thanks for your time
