

RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.


Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Review of the Coastal zone policy areas and policy should be carried out now within this plan or at the very least a relaxation of the policy in the obvious non Coastal portions of the Zone.

Reason for change:

The Coastal Zone policy covers large areas of land some of which are no where near the coast nor form a Coasal Vista and are visually rural (Countryside).

We understand that there is a review proposed in 2022 but this is too far off and is restrictive to development in the short term particularly in the more remote areas and also in the regeneration areas. In these uncertain times development should not be constrained.

The defined Coastal zoned maps appear to have a simplistic definition of boundaries basically form the Coast line to the nearest major public road and due to their highly restrictive nature should have been more prescribed. Countryside policies should have also been permitted over these areas to allow flexibility of development.

Summary

We need greater flexibility within the Coastal Zone now for appropriate development in the appropriate location.
